# Social Inclusion Policy

**Recommendation:** that OSC recommends the Social Inclusion Policy be considered for adoption by Full Council

### 1. BACKGROUND

- 1.1 The most recent Comprehensive Performance Assessment (CPA) recommended the Council put in place a Social Inclusion Policy. This is further supported by the findings of the Assessment of Services (2007) which highlights the need for the Council to ensure its services are accessible to all.
- 1.2 Copeland Borough Council therefore needs a Social Inclusion Policy which once adopted and implemented should see social inclusion as an integral part of the work of CBC, and thus ensure that the work of the Council at all levels, is socially inclusive. By preventing social exclusion, the council will further enhance the well-being of all Copeland residents.
- 1.3 Adoption of the policy will make a direct contribution to the Corporate Plan, in particular to the Equality of Opportunity strand.

## 2. ISSUES TO BE CONSIDERED

- 2.1 Without a Social Inclusion Policy Copeland Borough Council cannot satisfy the recommendations of the CPA.
- 2.2 The policy itself will commit CBC to appropriate training for staff where necessary and involve enhanced consideration of factors affecting social inclusion in all of its work. However, once the latter becomes the norm, the policy will not be considered to create additional work.

- 2.3 With consideration of social inclusion at all levels, this will not only help guide the work that CBC does, if effective, it will prevent future problems arising as a result of social exclusion.
- 2.4 To be effective it will be necessary to monitor implementation of the policy across all departments within service reviews

#### 4. BENCHMARKING

4.1 All local authorities should have a Social Inclusion Policy, as was the recommendation from CBC's CPA. Policies do vary, and the one suggested for adoption by Copeland Borough Council is in comparison relatively detailed. However, this should ensure it is easier to implement and monitor.

## 5. PUBLIC CONSULTATION AND PUBLICITY

5.1 This policy if adopted will have a direct positive impact on all residents of Copeland.

## 6. CONCLUSION

- 6.1 Copeland Borough Council needs to adopt and actively implement a Social Inclusion Policy. A suggested policy is attached for recommendation to Full Council. Amendments will be considered from the OSC before presentation to Full Council if necessary.
- 6.2 Adopting a Social Inclusion Policy per se will not lead to the Council becoming socially inclusive. This policy must be actively implemented and monitored across all departments to see a real difference. This therefore requires that the Social Inclusion Policy is only put forward to Full Council if the OSC are satisfied there is sufficient commitment to implement the policy.
