The deed packet has been checked and there are no conditions placed upon the Council – this therefore is incorrect.

2. Drains, recently plumber called. Existing sewers drains get blocked extension will worsen. Flooding by extending building and car park

### Plumber event is irrelevant.

Drainage will be required to comply with development and Building Control – concerns expressed are unfounded, probably based on problems that occurred when Johnson House was first constructed.

3. Protection of trees. Protection of wildlife bats, squirrels, woodpeckers during work after work. Trees should be retained - tree protection order. Local amenity for people to visit to see wildlife

See photographs – the number of trees affected is low – the extension does not affect the bulk of the woodland. Purchaser has offered to set up a trust, involve English nature and residents to set up a management regime to properly manage the wood to enhance its quality for enjoyment of local people.

The number of `trees' is less than 10 and there will be little effect on biodiversity.
