1. Introduction

- 1.1 The Council has been carrying out a Best Value Review of Economic Regeneration under the auspices of a Steering Group chaired by Councillor Connolly. The final report and action plan have been agreed by both the steering Group and the Economic Wellbeing Overview and Scrutiny Committee
- 1.2 The final report has been made available in the member's room for consideration. The Introduction and Summary and Section Four, the Action Plan are appended to this report. These are backed up by documentation of the process and background files available in the Best Value F Drive on the Council's intranet.

2. Key Issues

- 2.1 The review began in 2004 with the Steering Group holding it first meeting in September. It has taken place out over an extended period of time due to the effects of Council restructuring on the capacity of the service to carry out the review. As a consequence, significant progress in implementation of actions on the ground has already been undertaken and these are described in Section Three of the report.
- 2.2 During the period of the review West Cumbria partners have jointly agreed to carry out a major review and master planning exercise of the area. This work will challenge current thinking and strategy, produce a new strategy and action plan, short and long term programmes, funding plans and identify what will need to change organisationally and procedurally to ensure effective delivery. As it is inappropriate for the action plan from this review to instigate anything that will duplicate this process, a number of pieces of work arising have been written into the brief for the master plan.
- 2.3 Members are asked to consider if there is anything they feel that should be changed in the action plan (Section 4) that can be supported by the evidence included in the work that has preceded it
