1. INTRODUCTION

1.1 The Councils parks team currently carry out the Grounds Maintenance Contract for Home North West covering the Copeland, South Lakes, Carlisle and Eden areas. It is a four year contract due for renewal in April 2014.

1.2 Notification has been given that Home North West intends to put the contract out to tender again starting the process in June 2013. At this point a decision will be made if the new contract will cover the same geographical area although indications are this will be the case.

1.3 The current contract has operated successfully during the last three years, with the council's team delivering all aspects of the contract to current specification, providing a high quality service to Home Group and its customers in line with their service specification.

1.4 The current contract accounts for work of four full time (equivalent) employees and seven seasonal operatives for the summer months. It is likely that the provisions of TUPE will apply to the full time posts.
