WHAT BENEFITS WILL THESE PROPOSALS BRING TO COPELAND RESIDENTS?

The 2010-2013 Copeland Climate Change Action Plan aims to help Copeland reduce greenhouse gas emissions and adapt to the impacts of climate change.

WHY HAS THIS REPORT COME TO THE EXECUTIVE?

To update the Executive on progress against the Copeland Climate Change Action Plan, and to seek approval for refreshed actions for 2012/13.

RECOMMENDATIONS:

A refresh of the Copeland Climate Change Action Plan has been prepared in support of the Cumbria Climate Change Commitment which the Council signed up to in March 2009.

Executive are requested to:

- a) Note the progress against the Copeland Climate Change Action Plan.
- b) Approve refreshed actions for 2012/13.

1. INTRODUCTION

- 1.1 Climate change is a long-term threat to our prosperity and wellbeing. Councils are uniquely placed to tackle climate change, acting as a link between international and national legislative commitments and local community action.
- 1.2 Following consultation with Members, Officers and key partners, a three year Copeland Climate Change Action Plan was agreed in June 2010 by Executive which supports the Council's commitment to the Cumbria Climate Change Commitment.
- 1.3 The Copeland Climate Change Action Plan sets out a strategic objective to work with partners and the Copeland community to address climate change and is accompanied by a series of Copeland specific priorities to:
 - Reduce the Council's carbon footprint and adapt our services and activities to the impacts of climate change.

- Support the provision of affordable and sustainable housing while addressing fuel poverty.
- Use our Local Development Framework as a strong tool for tackling climate change.
- Engage effectively with residents, communities, partners, businesses and visitors to help them mitigate and adapt to the consequences of climate change and playing our part in support of Britain's Energy Coast.
- 1.4 These priorities are accompanied by individual actions and detail on how they will be measured and who will deliver them.
- 1.5 The Copeland Climate Change Action Plan supports and links with other Council strategies and work programmes including our Local Development Framework, Copeland Housing Strategy, Asset Management Plan, Regeneration Plan, our Copeland Partnership Plan and the 2012/13 Council Plan.
- 1.6 Notable achievements of the plan to date include the following:
- 1.7 The completion of a Carbon Management Plan with support from the Carbon Trust. The Plan covers emissions associated with the council's buildings, fleet mileage, business mileage and street lighting. The Plan sets a target of achieving a 25% reduction in carbon emissions by March 2015 and details how this will be achieved. A 7.6% reduction was made in 2010/11. Projects implemented to date include the installation of LED lighting, an air source heat pump and voltage optimisation technology, the upgrade of heating, lighting and I.T systems, business mileage reduction, changes in working and fleet management practices and the procurement of fuel efficient vehicles.
- 1.8 A number of projects have been delivered to increase the uptake of energy efficiency measures by householders. In 2010, 288 insulation measures were installed across the borough and in 2011 the Cumbria Warm Homes Project was launched offering free household energy surveys and free or subsidised energy efficiency measures.
- 1.9 The Council has worked closely with Cumbria Business Environment Network to encourage businesses to take up free advice on how to reduce their resource consumption. This work includes the delivery of a Copeland Low Carbon Business Grant which has enabled a range of businesses to install energy efficient equipment with an overall reduction of 90 tonnes of carbon.

- 1.10 Staff from across the Council have taken advantage of free training including advising householders on energy efficiency and renewable energy, a greener museums programme and fuel efficient driver training.
- 1.11 A summary of progress against the actions approved in 2010 is shown in appendix A.

2. PROPOSALS

- 2.1 The purpose of this report is to give an update on progress against the plan and to present refreshed actions for 2012-13. A progress report and refreshed action plan are provided as appendices to this report.
- 2.2 The refreshed actions will enable the Council to continue delivering on commitments made to tackling climate change and enable the Council to respond effectively to recent changes in policy, for example the government's Green Deal.
- 2.3 The plan will continue to deliver on our climate change priorities outlined in the introduction which were agreed by the Executive in 2010. This report recommends only refreshing the actions and not the priorities. The priorities will be revisited in 2013 which is the final year of the overall three year plan and will be done in consultation with our partners.
- 2.4 Actions will be delivered by using existing staff and resources, working in partnership, reviewing current policies, practices and procedures and maximising funding opportunities.
- 2.5 We will work in partnership on areas such as contract delivery e.g. North Country Leisure, training, locality planning, procurement, business support, regeneration delivery, our coastal initiative and delivering affordable warmth schemes.

3. ALTERNATIVE OPTIONS TO BE CONSIDERED

3.1 To deliver no new actions on climate change due to limited resources or changing priorities.

4. CONCLUSIONS

4.1 The issue of climate change poses many challenges and opportunities for the residents, communities, partners, businesses and visitors to Copeland Refreshing our Climate Change Action Plan demonstrates leadership in tackling climate change and moving the borough towards a low carbon and sustainable future.
