1.0 Supporting Information :

Type of Breach

- 1.1 This report updates Members on current planning enforcement issues and follows a similar report presented at the 20th July 2011 Planning Panel meeting.
- 1.2 From July 1st 2011 to November 30th 2011 the Council have received 134 complaints regarding alleged breaches of Planning Control, in addition to the 107 complaints regarding alleged breaches of planning control that were unresolved previously
- 1.3 The Complaints can be broken down as follows:-
