PP15/13 Minutes

The Minutes of the meeting held on 17 July 2013 were signed by the Chairman as a correct record.

PP16/13 Declarations of Interest

Councillor Jackie Bowman declared a non-pecuniary interest in Planning Application 4/13/2173/0F1. Application for the Installation of a single 250kw Wind Turbine (with a maximum height of 45.5m to blade tip) and Associated Infrastructure at Land at Stubbsgill Farm, Distington due to the application site being visible from her home.

PP17/13 Arrangement of the agenda

The Panel was advised that due to members of the public being present, Application Number 3 would be considered after Application number 1.

PP18/13 Planning Applications

Due to members of the public being present the following applications were dealt with at this point of the meeting.

4/12/2532/0F1 – application for Use of Land to provide short term Holiday Accommodation with Static Lodges, Touring Caravans & Camping Pods; Erection of Shower Block & Installation of sewage treatment Plant at Land at Lamplugh Tip, Frizington.

During discussion of this item Mr N Henderson spoke on behalf of Mr W Sharpe in objection to the application.

The Applicant, Mr B Spencer exercised his right to respond.

RESOLVED – That delegated authority be given to the Head of Nuclear, Energy and Planning to grant planning permission subject to:

- a) no adverse comments being received following consultation with Natural England.
- b) the removal of condition 16, and
- c) the addition of two new conditions, as follows:

Additional Condition 1

"No development shall commence on site until a scheme for intrusive ground investigations to assess the nature and extent of any contamination on the site; and a Phase II site investigation report and risk assessment, incorporating a proposed scheme of remediation for any contaminated land subsequently identified, has been submitted to and agreed in writing by the Local Planning Authority (LPA). No construction of the holiday homes hereby permitted and no excavation for laying drainage ditches, pipes or other water or sewage carrying infrastructure shall take place until the aforementioned scheme of intrusive-investigations and the approved remediation scheme have been carried out."

Additional Condition 2

"The holiday homes and camping area hereby permitted shall not be occupied until a contaminated land validation report, demonstrating successful remediation of the land in accordance with the approved remediation scheme, has been submitted to and approved in writing by the Local Planning Authority."

4/13/2213/0F1 – application for Variation of Condition 3 of Planning Permission 4/12/2170/0F1 to extend the period of permission from 20 years to 25 years at Fields 4400 & 6382, Land adjacent to Watch Hill, Low Moresby, Whitehaven.

During discussion of this item Mr M Carter spoke in objection to the application

RESOLVED – That in accordance with the Planning Code of Conduct, the application be Deferred as Members were minded to refuse the application against the Planning Officer's recommendation.

The remaining Planning Applications were dealt with at this point of the meeting.

RESOLVED – That applications for planning permission be determined as shown on the schedule hereto, subject to conditions of approval and reasons for refusal as set out in the report of the Head of Nuclear, Energy and Planning dated 14 August 2013.

PP19/13 <u>Deferral of Planning Application 4/11/2568/0F1 Erection of 33 Dwellings and Associated Infrastructure, Land off Links Crescent, Seascale</u>

Members were reminded that at the last Planning Panel meeting held on 17 July 2013, they were 'Minded to Refuse' this application against the Planning Officer's recommendation and in accordance with the Council's Planning Code of Conduct it was deferred.

Paragraph 9 of the Planning Code of Conduct states that a final decision on the application is deferred to the next meeting of the Planning Panel. This deferral of the final decision being to allow time for further advice to be prepared, including the drafting of suitable reasons for refusal, as appropriate.

The Panel was advised that in this case, it had not been possible to collect and collate all the information within the intervening time period.

Members were therefore requested to further defer a decision until the next Planning Panel meeting due to take place on 11 September 2013.

RESOLVED – That Planning Application 4/11/2568/0F1 be further Deferred to the next Planning Panel meeting on 11 September 2013.

Members were informed of the outcome of a recent Appeal decision in respect of Springfield Farm, Bigrigg.

RESOLVED – That the decision to ALLOW the appeal be noted in the context of the Council's Local Plan Policies and also in relation to performance monitoring.
