**1 Introduction**

**1.1** - At its meeting on 6 December 2013 the Panel decided to conduct a Community Governance Review under Part 9 of the Local Government and Public Involvement in Health Act 2007 in the ward(s) of the Borough, namely Whitehaven and Cumbria. The purpose of the Review is to establish whether or not there is public support for the establishment of a panel for the area of governance in the ward(s) and to report to the Council on the results of the consultation and to recommend all stages of the Review except the making of a Community Governance Order – the formation of the Review.

**2 Resolution**

**2.1** - It is a priority for the Council to establish a Community Governance Review in the ward(s) of the Borough, which is the area under review and other areas in the Borough which are considered to be relevant to the Review.

**2.2** - The meeting of the Panel on 24 January 2014 agreed to establish an initial phase of consultation consisting of:

**a)** - a number of drop in sessions where local residents could have the opportunity of asking their views on the Review or on any other aspect of the Review to the Council or to the Panel; and
