Recommendation:

1. BACKGROUND

Green Space Strategy

- 1.1 Overview and Scrutiny members will be aware that a draft green space strategy has been produced and was brought to this committee previously, since that time the planning section have been working through an open spaces audit under the PPG17 guidance.
- 1.2 Improving the borough Green Space's is fundamental to making a better and more attractive place leading to improving the quality of life for local residents and attracting visitors to the borough. Green spaces also provide a focal point for the wider community and for all age groups providing places to play, exercise and relax in, as well as creating and supporting valuable habitats for wild fauna and flora.
- 1.3 The strategy also promotes the achievement of national green flags and the overview and scrutiny members will be aware of the Councils achievement in gaining 4 Green Flag awards and 3 Green Heritage Awards for a its green spaces during 2007, these Green Awards are underpinned by strong community involvement and establishment of Friends groups.
- 1.4 The Green Space Strategy supports the Councils priorities for 2008/9 "Providing high quality, clean streets and open spaces".

2. ARGUMENT

Green Space Strategy Issues

- 2.1 To create and identify the network of spaces which meet the needs of the community, to encourage bio-diversity and multifunctional spaces. There is a need to think strategically about the links green spaces have within the environment.
- 2.2 Audits of parks and green spaces to include a hierarchy system for survey purposes to filter the levels of service delivery of the parks within the Borough for example principle parks, neighbourhood parks, pocket parks, community greens and open spaces.
- 2.3 Areas included within the strategy are:-
 - Parks & public Gardens
 - Natural & semi-natural spaces
 - Green Corridors
 - Outdoor sports facilities
 - Amenity open spaces
 - Provision for children & young people
 - Allotments, community gardens & city farms
 - Cemeteries, churchyards & other burial grounds
 - Accessible countryside in urban fringe areas
 - Network of cycle/pedestrian routes
