**PROPOSED DIVERSION OF PUBLIC FOOTPATH No. 422008  
PARISH OF ST BEES (FORMERLY ROTTINGTON)  
DISTRICT OF COPELAND**

I will be pleased to receive any comments that you might wish to make regarding the proposed diversion of above-mentioned footpath, as shown on the attached.

**Description of the Existing Route** (with reference to the plan)

From point 'C' at its junction with public footpath No.431039 the existing route runs in a generally westerly direction to point B, a distance of approximately 380 metres.

**Description of Proposed Route** (with reference to the plan)

From point 'A' where it would meet public footpath No.431039 proposed route would run in a generally westerly direction for a distance of approximately 398 metres to point 'B' where it would join the route to remain.


**Reason for Diversion**

The diversion is required by the applicant to facilitate further extraction of sandstone from the quarry.

**Works Required**

At present the proposed route for the diversion is not walkable. However, the Capita Symonds has stipulated the works that the applicant will be obliged to complete in order to provide a suitable walking surface prior to the confirmation of the associated legal order.




