Recommendation: that the decision of the Children, Young People and Healthy Communities Overview and Scrutiny Committee to support, in principle, the North Cumbria Acute Hospitals NHS Trust's application to become an NHS Foundation Trust be confirmed.

1. INTRODUCTION

The Children, Young People and Healthy Communities Overview and Scrutiny Committee considered at its special meeting on 21 November 2007 the application by the North Cumbria Acute Hospitals NHS Trust to become an NHS Foundation Trust.

The Committee considered the consultation document on these proposals which is attached at Appendix "A". It also received a presentation from Marie Burnham, Chief Executive and Caroline Griffiths, Director of Strategic Planning and Corporate Governance

The Committee questioned Ms Burnham and Ms Griffiths on a number of points. It noted that a foundation trust would have greater financial and legal freedoms than NHS Trusts and would be based on a "co-operative" model.

Whilst the Foundation Trust was still part of the NHS it would be publicly owned and the Council could be part of this process through having a representative on the Council of Governors.

The Committee agreed that in principle, the North Cumbria Acute Hospitals NHS Trust's application to become an NHS Foundation Trust should be supported by the Council.
