1. <u>INTRODUCTION</u>

- 1.1 Council on 1 March approved changes to the Scheme of Delegation to the Executive and Committees to reflect changes in management following corporate restructuring, and changes to Contract Standing Orders to reflect new procurement requirements.
- 1.2 This report presents the remaining parts of the constitution, which have been amended to reflect changes following the first phase of corporate restructuring, and other issues as explained below.
- 1.3 Further changes are proposed for Executive Portfolios, which are the subject of a separate report to this meeting.

2. SUMMARY OF AMENDMENTS

2.1 Part 1 – Articles of the Constitution

These have been amended to reflect changes in management following the first phase of corporate restructuring and include a new Mission Statement and Core Values which have already been the subject of consultation with Members at draft stage in late 2004. The relevant changes are shown in Article 1.

2.3 Part 4h – Officer Employment Procedure Rules

Part 4h has been amended to reflect changes in legislation on mandatory Standing Orders, which the Council must adopt, relating to the recruitment and appointment of the Head of the Paid Service, other chief officers and service heads and other officers, and procedures for the taking of disciplinary action against the holders of these posts. The necessary changes are shown in the revised Part 4h attached.

2.4 Protocol on Member/Officer Relations

This is a new provision which is not a statutory requirement but which local authorities have been strongly advised to adopt under the CIPFA Code of Corporate Governance and ODPM best practice guidelines on local authority constitutions. The protocol has been subject to informal discussions with the 2 main political groups.
