**PROPOSED CREATION ORDER FOR A PUBLIC BRIDLEWAY ALONG FELL LANE,
PARISH OF WABERTHWAITE**

I enclose a plan showing the proposed creation of a public bridleway along Fell Lane, linking bridleway 428011 with public road U4064, as shown on the attached map.

The western end of bridleway 428011 terminates at the eastern end of Fell Lane. Users of the bridleway then continue along this stony laning to the public road U4064. The proposed creation route A – B is well used as a bridleway, linking Waberthwaite with Ulpha across Waberthwaite Fell. We would like to formalise the situation of people using a route with no recorded rights along it. The length of the bridleway to be created is 410 metres.

I consider this new route to be beneficial to the public and a worthwhile addition to the public right of way network. Before any decisions are taken on this matter by the Corporate Operations Director, I would be grateful for your views so that your comments can be taken into consideration.

A response by Friday 16 September 2005 would be much appreciated.

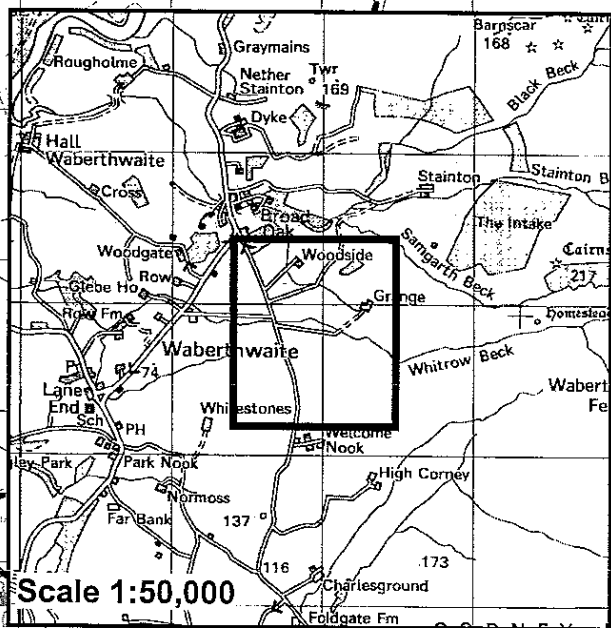
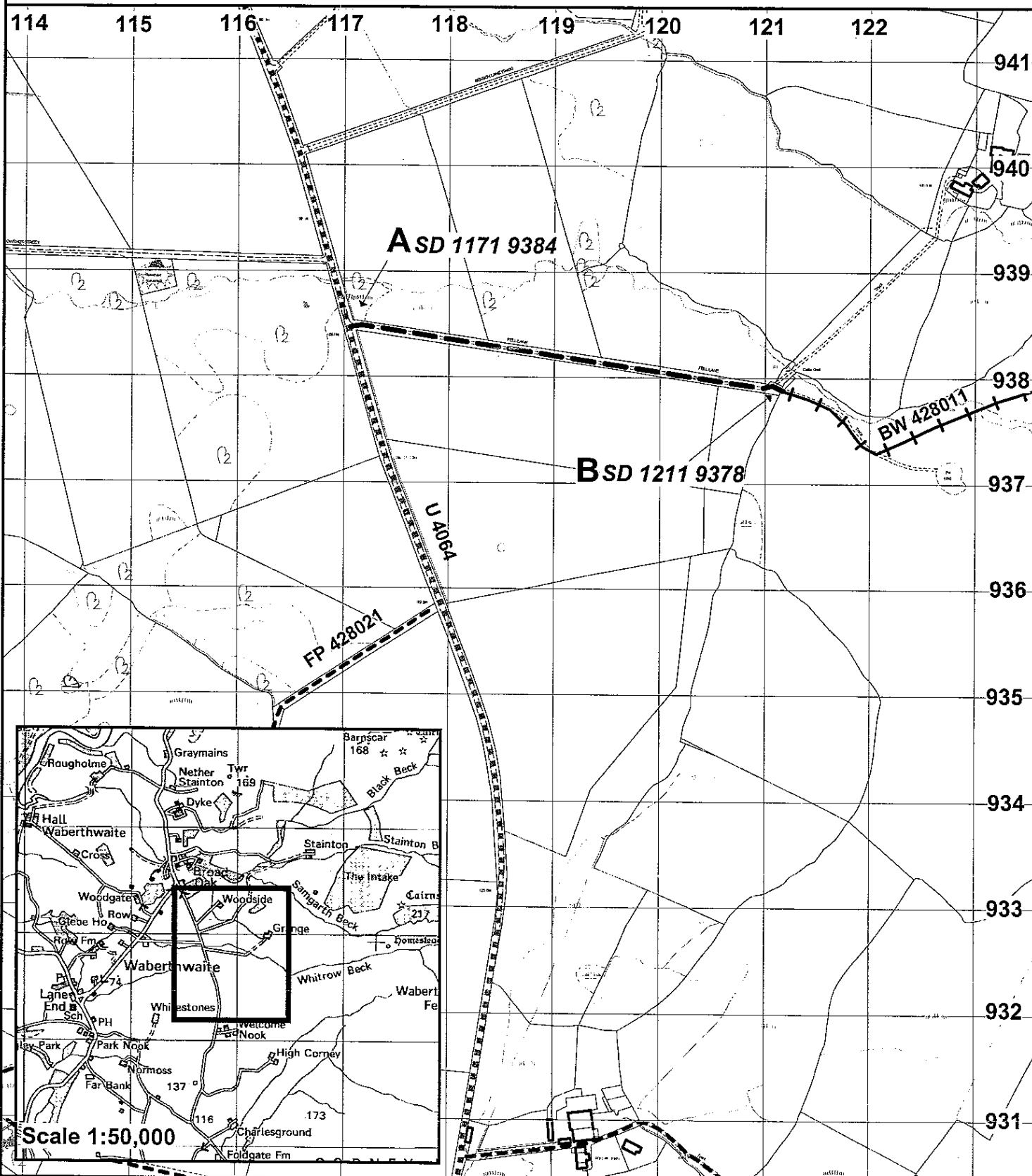
