- d) the programme of work set out in section 2 of this report to be incorporated into a Revised Local Development Scheme and this document be formally submitted to the ODPM; and

e) the use of £23,000 earmarked reserve set aside as a result of carry forwards from 2004/05 as part of the financing of the programme of work be approved.
