1. BACKGROUND

1. A local area agreement is a three year agreement, based on local sustainable communities strategies, that sets out the priorities for a local area agreed between Central Government, represented by Government Office, and a local area, represented by the lead local authority (here Cumbria County Council) and other key partners through local strategic partnerships (here Cumbria Strategic Partnership).

2. The primary objectives of a local area agreement is to deliver genuinely sustainable communities through better outcomes for local people. LAAs also have the secondary objectives of:

- improving central and local government relations;
- enhancing efficiency;
- strengthening partnership working;
- offering a framework within which local authorities can enhance their community leadership role.

3. The LAA framework replaces a number of other Government programmes and special funding streams (such as Single Regeneration Budget, Health Action Zones, Sports Action Zones and so on) to simplify the benefit, and to improve efficiency in assessment.

4. As described above there is a link between LAA and LSPs and their community strategies. The LAA will be the Cumbria-wide agreement with the Government that each LSP (such as the West Cumbria Strategic Partnership) seeks to deliver through its local community strategy. This is a new arrangement and will require even more accountability for the work of the LSPs to local people as well as to Government.

5. The LAA comprises a number of outcomes with targets chosen from a generic list but shaped to suit local circumstances. The latest version of the draft outcomes framework was published on 18 August on the Cumbria Strategic Partnership website. In agreeing the outcomes to be achieved in the LAA, stretch targets will be set which could result in financial rewards if they are achieved. However it is unlikely that they will be of such an extent as to influence deployment of resources locally or prioritisation, although substantial failure to achieve them could result in clawback.

In Cumbria

6. There have already been two rounds of LAAs in other areas of the country and Cumbria is in the third and final round. In Cumbria a pilot for one aspect of LAAs activities (the safer, stronger communities theme) has already been concluded and has been in operation since April 2006. Development is being led through the County Council and a number of groups have been set up which are managing the identification and refinement of outcomes.

7. Cumbria County Council and the Cumbria Strategic Partnership (CSP) working with the constituent groups in the CSP, are proposing five themes for the LAA:

- safer communities
- healthier communities and older people
- children and young people
- economic development and enterprise
- cross-cutting issues (including sustainability)

Thematic groups are actively working on the content of each of the themes and ensuring that there is cross-theme working to prevent the development of silos.

8. The timetable for negotiating and concluding the LAA is very compressed. Government Office for the North West required the first draft of the outcomes for the Cumbria LAA is with them by 30 June. Thereafter work continued over the summer to work up a draft agreement which is required by GONW by 30 September. The final draft agreement is required by 1 December, and it receives Ministerial sign off on 10 February 2007. Between 30 September and 1 December work will continue at local level to confirm or amend the content of the draft LAA outcomes. It is envisaged that this will be the main opportunity for district councils to be consulted upon the detailed contents of the LAA.

9. There is a communications strategy associated with the work on developing the LAA and Copeland members will be provided with information as it becomes available. The West Cumbria Strategic Partnership is engaged on behalf of the Council in a number of the groups. Individual Council officers are supporting LAA thematic groups (see the report elsewhere in the agenda concerning the development of the economic and enterprise theme). Events will take place during the autumn to which Copeland Borough Council members and officers will be invited. In order to understand and agree the scope of the LAA, it is important that these opportunities are taken up.

10. A joint scrutiny body representing members of the West Cumbrian authorities has been challenging the work to develop the LAA as it progresses. The main findings of this scrutiny work to date are that the communication around the development of the LAA could have been more comprehensive and that representation particularly from district authorities could have been more systematically planned.
