1.0 INTRODUCTION

1.1 The Action Plan is the single performance improvement plan for the Strategic Housing service in 2010/11 following its re-inspection, service planning, partner input advised and monitored by the Strategic Housing Panel.

1.2 The Strategic Housing Panel monitor the implementation of the Action Plan on a bi monthly basis and sign off completed actions and discuss exceptions. The full action plan has been considered by the Audit Committee who receive quarterly exception reporting against actions.

2.0 ACTION PLAN

2.1 All activities within the action plan have been undertaken. There are three actions where activity to fully complete in line with the plan have been delayed or rescheduled. These which were highlighted in the previous report to this Committee are:
