Action proposed: To place an advert in the local press to invite applications for an ad hoc list of contractors for the Christmas Lighting contract for 2005				
Financial/Resource Implications: Contract payment from existing Christmas Lights budget				
Background information:				
Executive approval was given to combine the Footway Lighting and Christmas Lighting contracts in a new contract and explore the possibility of a partnership agreement to cover 3 years. This combined contract will be caught by the EC threshold, which means under the restricted procedure, we need to invite expressions of interest in OJEC. Heeding legal advice, and due to staff capacity, it is now unrealistic to have a combined contract in place before we need to erect the Christmas lights for this year's festive period. Prompt action is necessary if we are to get the Christmas lights erected in time. To this end an advert will be placed in the Whitehaven News this week inviting applications for inclusion on an ad hoc list for the Christmas Lighting contract.				
A combined lighting contract will be put out to start in April 2006, but as this differs from what was agreed originally by Executive we will report these actions to the next Executive meeting
