#### WHAT BENEFITS WILL THESE PROPOSALS BRING TO COPELAND RESIDENTS?

Social investment resources will be used over five years to fund discretionary services to our residents around discretionary access to leisure and environmental improvements in the first two years (2014-16) and including financial and social inclusion related services in years 2 to 5 (2015-19).

#### WHY HAS THIS REPORT COME TO THE EXECUTIVE?

(e.g. Key Decision, Policy recommendation for Full Council, at request of Council, etc.) Executive have requested an update on the Energy Coast Social Investment Fund and are being requested to agree the receipt and conditions of receiving this grant.

#### **RECOMMENDATIONS:**

Executive are asked to

- a) formally endorse the social investment fund priorities for Copeland; and
- b) agree the receipt and approve the spend profile as set out in the report of £400,000 social investment grant each year to the Council to deliver existing discretionary services as detailed in the report during 2014 to 2019.

#### 1 INTRODUCTION

- 1.1 The Energy Coast West Cumbria (ECWC) Ltd Board agreed at its meeting in August 2013 to set up a Social Investment Fund of £1,000,000 per annum from April 2014. The two West Cumbria District Councils were invited to identify priorities for social investment funding resource to use the annual resource.
- 1.2 A Service Level Agreement was developed by ECWC and Copeland Council to set out the arrangements for the funding to each District Council. This is attached at Appendix A. The funding is offered to enable social conditions for growth within each district area to underpin the West Cumbria Economic Blueprint.

#### 2 PROPOSALS

- 2.1 Copeland Borough Council set out their priorities for the social investment to ensure social and environmental services that underpin the economic activity for sustained communities, to enable a healthy workforce and provide the conditions that assist companies and workers in recruiting and retaining staff to both live and work in the borough of Copeland.
- 2.2 The Council has linked the social investment funding to three discretionary service areas that are potentially at threat by the public sector cuts but which are important to maintain and build the health and wellbeing of the Copeland workforce and potential workforce. These are:
  - Copeland environmental improvement scheme
  - Access to leisure
  - Social inclusion
- 2.3 Appendix B sets out the Social Investment proposal to the Energy Coast including
  - a) the key data and evidence to support the focus of the social investment funding in Copeland;
  - b) the funding profile over the five years;
  - c) the detail for each of three priority areas including the output and outcomes.
- 2.4 The social investment activity provided by the council will be managed in line with the Council's Performance Management systems and monitored on a quarterly basis. These quarterly reports will be provided to the funder along with an annual report on the full use of the social investment funding in Copeland including the environmental works programme.
- 2.5 The environmental improvements will be undertaken by Works 4 You against a licence from the Council for sites throughout the borough with a set of minimum quality standards. Works 4 You currently undertake a range of contracts and activity throughout the borough and will be working with local partners (Parishes, Copeland Council and the locality partnerships) to ensure maximum synergy of activity. In particular they will be enabling local feedback through an annual review of past works and planned future work.

#### 3 ALTERNATIVE OPTIONS TO BE CONSIDERED

3.1 The council has taken the option to use social investment funding to underpin existing and recently provided discretionary services provided by the Council. The other option would be to use the money to commission new services. This would result in the Council needing to stop further services which currently underpin the economic blueprint through its commitment to assist growth.

#### 4 CONCLUSIONS

- 4.1 Copeland Council has used its influence with the Energy Coast West Cumbria Partnership to get agreement to resources for social investment to underpin the Economic Blueprint across West Cumbria. The Copeland Borough Council's proposal for a minimum of £500,000 annual resource will enable Copeland based activities that complement the West Cumbria Economic Blueprint. Our proposal is for five years in line with the commitments to delivery of social investment activities. The social inclusion activities already provided by the Council will be supported by this fund alongside additional programme activities in year 4 and 5 (2017-19). The annual monitoring and review of impact and delivery outcomes may result in amendments to the proposed use of the Social Investment Fund in Copeland.
- 4.2 The annual resource available will be used for the social investment purposes as

laid out in Appendix B and in line with our evidence base. The Executive are being asked to accept the receipt of social investment grant of £400,000 per year from Energy Coast West Cumbria for the next five years to deliver the social investment activities as set out in this report.

#### 5. RESOURCE IMPLICATIONS

5.1 The social investment grant to the Council will be received as an annual grant in one sum at the beginning of each year. The reporting requirements are covered in 2.4. The grant will be used to resource discretionary services in support of social conditions for growth which in turn underpin the West Cumbria Economic Blueprint.

## 6. STATUTORY OFFICER COMMENTS

- 6.1 The Monitoring Officer's comments are: No additional comments
- 6.2 The Section 151 Officer's comments are: The Social Investment Fund is to provide £400k as a grant to CBC direct and £100k as a grant to Works 4 direct, for works to be carried out for CBC, under licence.

The SLA is taken to provide all grant conditions, and within this document there is no risk of claw back to the authority, however the SLA states 'the social fund will provide resources from April on a yearly basis until stopped by the decision of the BEC Board'.

So this guarantees funding for 2014/15 but not beyond. The MTFS approved by Council in February this year included £400k a year support so any withdrawal of this funding after April will result in future years budget gap increasing, as will supporting any activity not currently budgeted for.

The Council should not therefore enter into any contracts with third parties to carry out works detailed in this report, extending beyond a year, until each years funding is approved. It is recommended that executive receive a report detailing actual spend to date and funding received, as well as proposed spend and confirmed funding levels in November of each year to enable the annual budget strategy to be confirmed.

There will be a separate grant letter awarded to Works 4 U direct for £100k a year, with the only obligation to CBC being; to include their monitoring with ours, which will be done through the Head of Customer and Community Services.

The Head of Regeneration and Communities has stated the current procedures in place within the authority for reporting performance will be sufficient to satisfy the authorities commitments to ECWC under the terms of the SLA and that no further resource will be necessary.

- 6.3 EIA Comment: The Social Investment priorities for the Council will enable access to leisure and social inclusion support throughout the borough and to all residents with specific measures already in place, for example, through the BeActive Plus card for Leisure, to enable residents on low incomes to access resources and services.
- 6.4 Policy Framework Comment: The Council through its policy led budget process in 2012/13 identified discretionary services essential to the economic and social wellbeing of residents. This funding programme enables resources to assist discretionary services seen as a priority for residents by Copeland Borough Council to continue to be provided to underpin the social conditions for growth set out in the Economic Blueprint endorsed by the Council.

6.5 Other consultee comments, if any: Priorities have been identified by the Council's internal Change Board and supported in consultation with the Executive and Full Council as part of the budget setting process for 2014/15.

## 7. HOW WILL THE PROPOSALS BE PROJECT MANAGED AND HOW ARE THE RISKS GOING TO BE MANAGED?

- 7.1 The services provided by the Council will be managed through the existing routes and corporate framework. Services and strategic risk registers are in place and will be used to manage and mitigate risks.
- 7.2 Works 4 You will receive their grant directly from the Energy Coast and will be responsible for project and risk management for the environmental improvement. The Council will receive copies of their monitoring detail and we will include their outputs and outcomes in our annual report on the social investment fund in Copeland. The Council will not be responsible for dealing with any issues or complaints with regard to the environmental improvement activity, these will be dealt with directly by Works 4 You.

#### 8. WHAT MEASURABLE OUTCOMES OR OUTPUTS WILL ARISE FROM THIS REPORT?

8.1 The Council through its priorities for social investment resources from Energy Coast West Cumbria will be able to maintain discretionary service delivery in the three investment areas detailed above across the borough. This is directly in support of the social conditions which enable sustainable communities, deliver services which make the area more attractive to investors and workers locating and staying in the borough and support economic growth.

SERVICE LEVEL AGREEMENT BETWEEN COPELAND BOROUGH COUNCIL

& ENERGY COAST WEST CUMBRIA LIMITED

#### INTRODUCTION

In August 2013, the Energy Coast West Cumbria Limited (BEC) Board agreed to allocate up to £1,000,000 per annum of nuclear sector funding for the foreseeable future to be allocated for use by Allerdale Borough Council (ABC) and Copeland Borough Council (CBC) under the designation of a Social Fund. BEC officers were tasked with the administration of this new Social Fund and to monitor that the funding is allocated to projects, initiatives and programmes of work that complement BEC's West Cumbria Economic Blueprint (2012).

In discussion with partners it has been agreed:

- the Social Fund will be divided between the two local authorities of Copeland and Allerdale as agreed by the BEC Board;
- The Social Fund will provide resources from April 2014 on a yearly basis until stopped by a decision of the BEC Board;
- responsibility for delivery/commissioning of the projects, initiatives and programmes of work should be retained within each Local Authority;
- Management of the funding and monitoring of the outcomes achieved through the Social Fund would be done most effectively and efficiently through two Service Level Agreements, a separate one with each of the two Local Authorities.

#### COPELAND BOROUGH COUNCIL'S COMMITMENT

- 1. To present a formal Proposal for the use of a minimum of £500,000 in the 2014/15 and any further financial year by no later than 31st December, 2013 for processing and comment by BEC Operational Executive.
- 2. To demonstrate that Cumbria County Council (CCC), through whichever mechanism decided by Copeland Borough Council, has been consulted with and formally endorses the proposal.
- To hold the monies in a ring-fenced account entitled BEC Social Fund and from which CBC can manage the funding and from which payments can be discretely tracked.
- 4. To demonstrate that the projects, initiatives and programmes of work included in the Proposal achieve SMART (Specific, Measurable, Achievable, Relevant, Time-bound) Outputs and Outcomes and are aligned to the West Cumbria Economic Blueprint (2012), to include delivering social conditions for growth.
- 5. To provide quarterly reports against projects to BEC that include (i) evidence and purpose of expenditure, and (ii) reports on each of the projects, initiatives and programmes of work including particularly the Outputs and/or Outcomes achieved in the quarter and cumulatively Year-to-Date. Where the work has been commissioned directly through BEC at the Council's request, the commissioned deliverer to provide the quarterly reports directly to BEC.
- 6. Each quarter, reports against projects by the Council or commissioned project lead, will be provided in arrears by the end of the following calendar month i.e. the Q1 2014 report will cover April -June, inclusive, and be submitted to BEC by the end of July 2014 latest.

- 7. CBC agrees that BEC will not be liable to provide any additional funding above the agreed Social Fund allocation in any year to cover any overspend that is experienced on any of the projects, initiatives and programmes without a formalised prior discussion and comment at BEC Operational Executive.
- 8. CBC agrees that it will provide evidence of expenditure on projects, initiatives and programmes of work that have been formally processed through BEC Operational Exec against this Fund and will not make any claims for activities outside the approved or formally amended proposal(s).
- 9. CBC agrees to provide BEC with at least one months written notice of any changes that it may wish to introduce to the Proposal offer letter e.g. to drop a project stated in the proposal or to undertake a new project that does not appear in the proposal.
- 10. CBC agrees that it will through its reporting be clear of any carry forwards against the project delivery plans within the proposal from year to year. managing the proposal to maximise full spend of the Social Fund against evidenced priorities and will bring timely formal requests to BEC operational executive of any changes required to the Copeland Proposal in line with this.
- 11. CBC produces a BEC Social Fund Communications Plan and agrees to meet the requirements of the BEC Branding & Publicity Guidelines to ensure the investment by BEC and the relevant Nuclear Partner/s in the BEC Social Fund and the activities it supports are positively recognised.

#### BRITAIN'S ENERGY COAST'S COMMITMENT

- 1. To consider and provide feedback on the submitted proposal at the Operational Executive within two working weeks of receipt.
- 2. Subject to the formulation a proposal formally processed by BEC, to provide CBC at least £500,000 each year of the proposal in loine with the BEC Board Social Fund allocation decision.
- 3. To discuss and agree with CBC the preferred method of payment e.g. a single lump sum, phased payments or some direct payments to commissioned project leads. The key principle being that payments are made in advance.
- 4. That BEC will not seek payment of any interest accrued from monies held in CBC's ring-fenced BEC Social Fund account.
- 5. To undertake performance review on the Social Fund as part of the existing performance framework to ensure projects are demonstrating value for money and are contributing to the objectives of the BEC's West Cumbria Economic Blueprint

## The Access to Leisure Programme

This programme delivered by Copeland Borough Council focuses on enabling fitness, leisure and sports facility delivery and access by Copeland residents and visitors (both business and leisure). The grant enables the necessary subsidy and grant support to ensure the Copeland Pool and Fitness Centre, the Whitehaven Sports Centre, Cleator Moor Bowls Centre and Millom Recreation Centre are able to provide leisure and fitness facilities for economically active and inactive residents and workers in Copeland. Alongside providing the social infrastructure necessary in any sustainable community, the Access to Leisure Programme offers health and fitness benefits and impact to the local workforce and Copeland jobless residents. The access to leisure programme through providing the facility infrastructure unlocks complementary activity such as the GP fitness referral commission and the B-Active project supported by Copeland Community Fund taking fitness activities and resources from these facilities out into the communities across Copeland. The facilities are and will continue to be well used by schools and families providing wellbeing outcomes across the communities and neighbourhoods of Copeland. NCL will continue to develop and deliver their apprenticeship approach and training and work experience opportunities within their annual service arrangements. The Millom investment will enable match funding to maximise widening of access to leisure throughout the borough.

The leisure, sport and fitness sector is active in Copeland and the social investment from this Funding to the facilities and delivery will be used to match a complementary employability scheme commissioned by the Council – Pathways to Sport. This project is anticipated to be delivered by a partnership between Phoenix Enterprise, NCL and West Lakes College where the NCL element is provided through access to sports facilities and coaches under the social investment funding. The match funding will be a package which may include ERDF/ESF, Copeland Community Fund, Sport England/Sportivate and in kind and private sector funding. This scheme will be developed during 2014/15 with the intention of a small pilot within 2014/15 moving into a full 3 year scheme from April 2015.

## Copeland Environmental Improvement Scheme - to support Economic Growth

This three year programme of activity is being delivered against a brief provided by the Council and linked to a licence from the Council to social enterprise Works 4 You to deliver works between April and September annually. At its core the Scheme will provide environmental works which will contribute to maintaining the environmental quality within the Innovation Zone and hence contribute to the conditions for economic growth. The proposal is to enable locality engagement with the annual monitoring and scoping of the works resulting in an annual service plan.

Works 4 You was established as a social enterprise in 2006 and has built up a successful reputation of delivering environmental improvement initiatives across Copeland along with an excellent track record of providing local employment opportunities. It has grown and developed by securing more contracts allowing it to become increasingly robust and viable as a business. As a testament to its achievement in 2012 Works 4 You went on to win Social Enterprise of the Year in Cumbria.
