## **Summary and Recommendation:**

The report provides details of proper officer arrangements with the Health Protection Agency and Cumbria Primary Care Trust for Public Health Act and National Assistance Act 1948.

### The recommendations are:

1. That the Executive recommends to Full Council the appointment of seven consultant level staff of Cumbria and Lancashire Health Protection Unit named in the report as Proper Officers under Public Health (Control of Diseases) Act 1984 2. The Executive recommends to Full Council that specified named staffof Cumbria Primary Care Trust are appointed as the Proper Officers under National Assistance Act 1948

#### 1. INTRODUCTION

- 1.1 A number of organisational, legislative and personnel changes involving the Health Protection Agency and the National Health Service have been made recently which makes it important to update arrangements for Proper Officer functions for local authorities in Cumbria and Lancashire.
- 1.2 The Proper Officer is appointed by the local authority and local authorities are required to appoint Proper Officers for these functions at a formal Council meeting. The arrangements date to a time when these functions were carried out by local authorities, i.e. before the re-organisation of local government in 1974. With succeeding reorganisations within the Health Service delivery of the Proper Officer function has moved from organisation to organisation.
- 1.3 The Health Protection Act 2004 established the Health Protection Agency as a national non-governmental public body with broad responsibilities for protecting public health. A subsequent consultation between the Health Protection Agency and the National Health Service has agreed that the Health Protection Agency will provide Proper Officers for the Public Health (Control of Disease) Act 1984 functions.

- 1.4 Many health protection duties and requirements fall to local authorities rather than to the Health Protection Agency or Primary Care Trust.
- 1.5 The Chief Executive from the Director of the Cumbria and Lancashire Health Protection Unit has advised that each of the local authorities appoints the seven consultant level staff in the unit as Proper Officers under the Public Health (Control of Disease) Act 1984.
- 1.6 The proposal is based on the understanding that the nominated consultant will be the main contact for any enquiries, but that other consultants would be available to provide cover out of hours and for holidays, sickness or staff vacancies.
