**1. INTRODUCTION**

- 1.1 This report addresses a number of minor anomalies in Council appointments to outside bodies as detailed below.

**2. CUMBRIA COMMUNITY FOUNDATION AND WEST CUMBRIA GRANTS PANEL**

- 2.1 The Council is no longer entitled to any representatives on the Cumbria Community Foundation. Members are asked to note the position.
- 2.2 At the Council meeting in June, Councillors Geoff Garrity, Keith Hitchen and Elaine Woodburn were appointed to the Cumbria Community Foundation West Cumbria Grants Panel. It has since been clarified that the Council is entitled to

two representatives on the Panel, not three. Council is therefore asked to remove one of the representatives appointed in June.

**3. WEST CUMBRIA CYCLEWAY PARTERSHIP**

- 3.1 At the Council meeting in June, Council representation on the West Cumbria Cycleway Partnership was discontinued. It was agreed that the Council would continue financial support to the Partnership with officer support continuing at Partnership meetings.
- 3.2 Subsequently to this, the Partnership have pointed out to us that the Memorandum of Understanding between the Partnership and the Council stipulates that the Council will appoint a Member representative to the Partnership. In these circumstances, Council is asked to note the position and make a Member appointment.

**4. CUMBRIA PLANNING GROUP**

- 4.1 Council is asked to note and endorse the recent appointment of Councillor Michael McVeigh as the Council representative on the Cumbria Planning Group.
