RESOLVED - That a) the report be noted;

b) it be noted that the revised part of the scheme applies Guaranteed Pension Credit eligibility only and the value of the vouchers be increased to £28.00; and

c) the mitigating actions as detailed in section 4 of the report be agreed.

C 86 <u>Treasury Management Strategy 2012/13 – 2014/15 incorporating Annual Investment Strategy</u> 2012/13 and Minimum Revenue provision Statement 2012/13

The Council considered a report setting out the recommendations of the Executive on the Treasury Management Strategy, Annual Investment Strategy and Minimum Revenue Provision for 2012/13.

RESOLVED - That each of the key elements of the below named reports be approved:

- **1.** The Capital Prudential Indicators and Limits for 2012/13 to 2014/15 including the Authorised Limit Prudential Indicator at section 2;
- **2.** The Minimum Revenue Provision (MRP) Statement which sets out the Council's policy on MRP at section 3;
- **3.** The Treasury Management Strategy 2012/13 to 2014/15 and the treasury Prudential Indicators as at Section 4;
- 4. The Annual Investment Strategy 2012/13 as at Section 5;
- 5. To note the changes to the Strategy from last year as specified in sections 4.3 –Indicator for maturity structure of fixed interest rate borrowing 2012/13 and Limits on variable interest rates, investments only, and 5.2 Country limits.

C 87 <u>Revenue Budget Proposals 2012/13</u>

Consideration was given to the recommendations of the Executive on the Revenue Budget and Council Tax for 2012/13.

RESOLVED – That

a) the net Revenue Budget for 2012/13 at £11,050,425 including the use of earmarked reserves of £435,564, giving a net budget requirement of £10,614,861 to be funded from general grants £6,363,969, Council Tax of £4,029,436 unallocated general fund reserves of £221,456 as detailed in Appendix D of the report be approved;

b) the one year Government Grant offer, of £100,269, to freeze Council Tax at 2011/12 levels be accepted;

c) the following decisions that have been included within the 2012/13 Budget requirement be approved as a) & b) above

i) the proposals for increase in fees and charges as detailed in Appendix A of the report;ii) the net growth pressure in the budget totalling £588,352, set out in Appendix B of the report;

iii) the savings proposals in the budget totalling £1,817,171 as detailed in appendix C;

iv) the use of $\pm 221,456$ from General Fund balances in 2012/13 to support general expenditure;

v) the use of £435,564 from Earmarked Reserves and Sinking Funds to support specific expenditure in 2012/13; and

d) the view of the Corporate Director Resources and Transformation, as s151 officer, over the robustness of the budget estimates and level of reserves to comply with section 25 of the Local Government Act 2003.

C 88 Capital Programme for 2012/13 – 2014/15

Consideration was given to the proposed Capital Programme for 2011/12 to 2013/14

RESOLVED – That

- the Capital Programme for 2012/13 at £1,543,649 and future years 2013/14 and 2014/15 at £1,099,800 and £590,000 respectively as summarised in Appendix A of the report, subject to further appraisal of each scheme, via a PID/Project Brief being prepared and presented to and formally approved by Executive, prior to the commencement of spend be approved in principle; and
- (ii) the funding of the capital projects should capital receipts be delayed be approved as detailed in Appendix C and paragraph 4.3 of the report.

C 89 Use of Reserves

Consideration was given to a report setting out the Council's strategy for using its reserves and the balances that are available to provide support to the revenue budget.

RESOLVED – That a) the reserve strategy for 2012/13 as detailed in the report setting out the framework for the use and level of reserves in the future be approved; and

b) the level of reserves held by the Council as detailed in Appendix A of the report be approved.

C 90 Council Tax Resolution

The Council considered the Council Tax for 2011/12 taking account of the precept requirements of Cumbria County Council, Cumbria Police Authority and Parish Councils

RESOLVED – That a) the Council Tax requirement for its own purposes and the precept notified to it by Cumbria County Council; the Cumbria Police Authority and individual Parish precepts as contained in the report be noted; and

b) the level of Council Tax for the year be approved as appended to these minutes

The Council is recommended to resolve as follows:

- 1. It be noted that on 22 December 2012 the Council calculated the Council Tax Base for 2012/13;
 - (a) for the whole Council area as 22,264.80 [Item T in the formula in Section 31B of the Local Government Finance Act 1992, as amended (the "Act")]
 ; and
 - (b) for dwellings in those parts of its area to which a Parish precept relates as in the attached Appendix C.
- 2. The Council Tax Requirement calculated for the Council's own purposes for 2012/13 (excluding Parish precepts) is **£4,013,675.**
- 3. That the following amounts be calculated for the year 2012/13 in accordance with Sections 31 to 36 of the Act:
 - (a) **£43,424,926** being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(2) of the Act taking into account all precepts issued to it by Parish Councils.
 - (b) **£38,947,840** being the aggregate of the amounts which the Council estimates for the items set out in Section 31A(3) of the Act.
 - (c) £4,477,086 being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Council in accordance with Section 31A(4) of the Act as its Council Tax requirement for the year. (Item R in the formula in Section 31B of the Act).
 - (d) £201.08 being the amount at 3(c) above (Item R), all divided by Item T (1(a) above), calculated by the Council, in accordance with Section 31B of the Act, as the basic amount of its Council Tax for the year (including Parish precepts).
 - (e) **£463,411** being the aggregate amount of all Parish Precepts referred to in Section 34(1) of the Act (as per the attached Appendix C).
 - (f) £180.27 being the amount at 3(d) above less the result given by dividing the amount at 3(e) above by Item T (1(a) above), calculated by the Council, in accordance with Section 34(2) of the Act, as the basic amount of its Council Tax for the year for dwellings in those parts of its area to which no Parish precept relates.
