#### **COPELAND LOCAL PLAN 2001-2016 SAVED POLICIES**

This report details the Secretary of State's Direction on saved policies in the Copeland Local Plan

**Recommendations:** That Members note the terms of the Direction and the

particular policies in the Local Plan which have been retained for use until the Local Development Framework

brings in replacements.

#### 1. BACKGROUND INFORMATION

- 1.1 The Planning and Compulsory Purchase Act 2004 introduced a number of changes to the planning system including the Local Development Framework (LDF). LDFs consist of a suite of planning policy documents which will over time replace the Local Plans prepared under the previous regime. The 2004 Act allowed policies in Local Plans to be 'saved' or retained for use for a period of three years from the date of adoption of the Plan. After that 3 year period the policies would expire, unless formally extended as saved policies by the Council. The Copeland Local Plan was formally adopted in June 2006 so the exercise to agree which policies should be saved pending LDF production has been undertaken and the Secretary of State has accordingly issued a Direction.
- 1.2 Chapter 9 of the 2008 revision to Planning Policy Statement 12: Local Spatial Planning covers the issue of extending saved Local Plan policies. It states that in order to retain specified policies beyond June 2009 the Council needs the Secretary of State's agreement to this effect.
- 1.3 To obtain this agreement the Council was required to demonstrate that the policies it wished to extend reflected the principles of Local Development Frameworks and were consistent with current national policy.
- 1.4 Paragraph 9.2 of PPS 12 indicates the criteria that the Government takes into account in considering extensions to Local Plan saved policies. These criteria are:
  - A. Where appropriate, there is a clear central strategy;
  - B. The policies have regard to the Community Strategy for the area;

- C. The policies are in general conformity with the regional spatial strategy or spatial development strategy;
- D. The policies are in conformity with the Core Strategy Development Plan Document (where the core strategy has been adopted);
- E. There are effective policies for any parts of the authority's area where significant change in the use or development of land or conservation of the area is envisaged; and
- F. The policies are necessary and do not merely repeat national or regional policy.

### 2. COPELAND LOCAL PLAN 2001-2016 SAVED POLICIES

- 2.1 The Council submitted its application to the Secretary of State with those policies it wished to extend as saved policies and those it no longer wished to save.
- 2.2 The Secretary of State reviewed the Council's application and issued a Direction under paragraph 1 (3) of Schedule 8 to the Planning and Compulsory Purchase Act 2004. The Secretary of State's Direction and Schedule contains a list of those policies which have been saved. These are as follows:
