OSC1 22/10 Chairman's Opening Remarks

The Chairman began the meeting by welcoming Members, Members of the Public and the Press.

OSC1 23/10 Minutes

The minutes of the meetings held on 27 September 2010 and 8 November 2010 were signed by the Chairman as a correct record.

OSC1 24/10 Whitehaven Rugby League Football Club – Review of the Role of Council Members

The Chair reported that one Member had contacted her expressing concern that those interviewed by the Chief Executive had not been listed in the report.

The Chief Executive presented to Committee his report setting out the results of an investigation into the role of Council Members appointed to the Board of the Whitehaven Rugby League Football Club, as requested by this Committee on 27 September 2010.

This report included detailed answers to the specific questions raised by Members, together with a number of recommendations.

The main finding of the report was that although there are lessons to be learned by the Council, there was no evidence of improper conduct by Members that had led to any financial loss for Copeland Borough Council. The Chief executive explained that his investigation had determined that there were lessons to be learned by the Council in terms of processes and procedures, in particular relating to Members on outside bodies and reporting back, but there was no evidence of improper conduct by Members that had led to any financial loss for Copeland Borough Council.

Attention was drawn to recommendation ii) and it was agreed that Overview and Scrutiny would review reporting back procedures at its next meeting.

During a lengthy discussion that followed, Members also questioned further an amount of £500,000 held by West Cumbria Development Fund of which two withdrawals have been made. One amount of £100,000 and one for £44,530. It was requested that a copy of the West Cumbria Development Fund documents be made available to the Members and members of the Public present as an addendum to the main report.

Members thanked the Chief Executive for a thorough report.
