PP24/11 Minutes

The Minutes of the meeting held on 20 July 2011 were signed by the Chairman as a correct record.

PP25/11 Declarations of Interest

Councillor Geoffrey Garrity declared a personal interest in Application 4/11/2265/OF1 – Redevelopment of existing Hospital complex involving partial demolition, refurbishment of existing buildings, erection of replacement building and the provision of additional car parking and associated landscaping at West Cumberland Hospital, Hensingham, Whitehaven, Cumbria due to being Copeland Borough Council's representative on the NHS Primary Care Trust.

Councillor Stephen Haraldsen declared a personal interest in the same Application due to having family members working there.

Councillor John Jackson declared a personal interest in Application 4/11/2256/0F1 – Replacement Beach Bungalow at Copeland, Braystones Beach, Braystones, Beckermet, Cumbria due to having stayed at this property a number of years ago.

PP27/11 Planning Applications

Due to members of the public being present the following applications were dealt with at this point of the meeting.

4/10/9001/OF2 – Development of a Waste Management Facility for the disposal of Low and Very Low Level Radioactive Waste including site restoration & ancillary development at Keekle Head Former Opencast Coal Site, Pica, Workington, Cumbria.

During discussion of this item Councillor Elaine Woodburn, as Portfolio Holder for Nuclear Issues, spoke in objection to the application.

RESOLVED – That

 a) on behalf of the Council, this Panel recommends the application be Refused by the County Council due to the Council's non dispersal position with regards to radioactive waste.
Without details of the volume of waste involved and a full assessment of the capacity of existing sites which may be suitable for Very Low Level waste and the need for future capacity there is not considered to be an overriding justification and need for a waste management facility on this site. To approve this proposal without a full spatial assessment and consultation and the absence of necessary data would be inappropriate at the stage.

The Council did not consider that there was an overriding justification and need for a waste management facility on this site. The community and other benefits put forward were limited and were considered insufficient to outweigh the effects of this proposal. As a consequence, this proposal was considered to be contrary to Policy ST4 of the adopted Cumbria and Lake District Joint Structure Plan 2001-2016, Policies 1 and 3 of the adopted Cumbria Minerals and Waste Management Framework Core Strategy and Policies DEV8 and NUC1 of the adopted Copeland Local Plan 2001-2016, and

b) a letter be written to the County Council requesting that they instigate enforcement proceedings to secure restoration of the land at the earliest opportunity.
