4/13/2061/0F1 – application for the erection of wind turbine 45.5metres to blade tip height & associated metering units at Drigg Moorside Farm, Drigg, Holmrook.

During discussion of this item Mr M Harrington, Mr S Robb, Mrs H Pateman and Mrs M Deane spoke in objection to the application. Mr J Harley (Agent) exercised his right to respond.

4/12/2026/OF1 – application for the installation of 500KW Wind Turbine, with ancillary development including temporary access tracks & crane pads at Land to south west of Fairladies Farm, Outrigg Road, St Bees.

RESOLVED – That the application be Refused.

4/13/2103/0F1 – application for the erection of 40 No. Dwellings and Associated Infrastructure at Land at Site of Former Rhodia Offices, High Road, Whitehaven.

RESOLVED – That the application be Approved subject to the addition of the following conditions:

"14. No development shall commence on site until (i) a scheme for intrusive ground investigations to assess the nature and extent of any contamination on the site; and (ii) a Phase II site investigation report and risk assessment, incorporating a proposed scheme of remediation for any contaminated land identified in the course of such investigations, have been submitted to and agreed in writing by the Local Planning Authority (LPA). No construction of the dwelling houses hereby permitted and no excavation for laying drainage ditches, pipes or other water or sewage carrying infrastructure shall take place until the aforementioned scheme of intrusive-investigations and the approved remediation scheme have been carried out.

Reason

To protect the quality of controlled waters.

15. The dwelling houses hereby permitted shall not be occupied until a contaminated land validation report, demonstrating successful remediation of the land in accordance with the approved remediation scheme, has been submitted to and approved in writing by the Local Planning Authority.

Reason
