## PP01/12 Minutes

The Minutes of the meeting held on 25 April 2012 were signed by the Chairman as a correct record.

#### PP02/12 Declarations of Interest

Councillor Joan Hully declared a personal interest in Planning Application 4/12/2120/0F1 – Erection of a Single Wind Turbine at Drigg Moorside Farm, Drigg, Holmrook due to knowing one of the Objectors.

Councillor Stephen Haraldsen declared a personal interest in Planning Application 4/12/2221/0F1 – Extension to provide Gymnasium & Fitness Activity Spaces & the provision of an additional 61 Parking Spaces at Whitehaven Swimming Pool, Cleator Moor Road, Whitehaven due to being a member of North Country Leisure Copeland.

Mr C Willoughby declared a personal interest in Application 4/12/2173/OF1 – Wind Turbine on a 30M Monopole Mast at Bailey Ground Farm, Seascale, Cumbria due to being a Seascale Parish Councillor.

## PP03/12 Planning Applications

Due to members of the public being present the following applications were dealt with at this point of the meeting.

**4/12/2120/OF1** – Erection of a Single Wind Turbine at Land at Drigg Moorside Farm, Drigg, Holmrook, Cumbria.

Prior to considering this application, Members were advised by the Development Control Manager that the Applicant/Agent had lodged an appeal against non-determination in respect of this application, but that this had not yet been formally accepted by the Planning Inspectorate.

Following discussions with the Planning Inspectorate and having taken subsequent legal advice on the matter, Members were directed to consider the application in the normal way for a decision or a resolution to be made at this meeting.

During discussion of this item Mrs Susan White, Mr Stuart Robb, Mrs Pamela Clatworthy, Mr Neil Baines, Mr John Thompson, Mr Bob Metcalf, and Mr Mike Harrington spoke in objection to the application.

**RESOLVED** – That the application be Refused.

**4/12/2173/OF1** – Wind Turbine on a 30M Monopole Mast at Land at Bailey Ground Farm, Seascale, Cumbria.

During discussion of this item Mrs Sonia Batten spoke in objection to the application. The Applicant's Agent Mr Paul Bailey exercised his right to respond.

**RESOLVED** – That the application be Approved, subject to the addition of a further condition:-

"4. Noise emissions from the wind turbine to which this permission refers shall not exceed 35dB LA90 (10 minutes) or 5dB above the measured background level when measured at any point at the façade of any residential or other noise sensitive boundary. For the purposes of this permission background levels shall be those levels of noise which occur in the absence of noise from the turbine to which this permission relates, expressed in terms of an A-weighted, 90<sup>th</sup> percentile level, measured at an appropriate time of day and for suitable period of time not less than 10 minutes. The microphone must be positioned 1.2 to 1.5m above ground level, fitted with a suitable windshield and situated in "free field conditions" external to any residential property, in accordance with the requirements of BS4142.

Reason:

To protect neighbouring amenity from noise pollution."

The remaining Planning Applications were dealt with at this point of the meeting.

**RESOLVED** – That applications for planning permission be determined as shown on the schedule hereto, subject to conditions of approval and reasons for refusal as set out in the report of the Development Control Manager dated 23 May 2012.

## PP04/12 Street Naming and Numbering

Consideration was given for a street name for an existing cul-de-sac of 10 houses at Outrigg, St Bees, Cumbria.

**RESOLVED** – That the street name Outrigg Close, St Bees, Cumbria be adopted for the cul-de-sac and all the relevant bodies be notified.

## PP05/12 County Council Planning Decision

Members were informed of a recent decision by Cumbria County Council for the creation of a waste management centre for the disposal of low and very low level radioactive waste at the former opencast site at Keekle Head near Pica.

**RESOLVED** – That the decision to Refuse planning consent be noted.
