### PP60/13 Planning Applications

**4/13/2323/0F1** – application for the Construction of a Two Storey detached Dwelling at Land to Rear of 108 Main Street, Haverigg, Millom, Cumbria.

During discussion of this item Mr S Mossop, Mr J Proctor and Ms E Houston, spoke in objection to the application. Mr C Reeve, representing the Applicant, exercised his right to respond.

**RESOLVED** – That the application be Approved.

**RESOLVED** – That applications for planning permission be determined as shown on the schedule hereto, subject to conditions of approval and reasons for refusal as set out in the report of the Head of Nuclear, Energy and Planning dated 26 February 2014, subject to:-

**4/13/2440/0F1** – Proposed siting of 1 x 30m High (Hub) Endurance Wind Turbine with a tip height of 45m at Land at Bailey Ground Farm, Santon Way, Seascale.

**RESOLVED** – that the application be Refused,

Reason: The proposed single turbine, 45.071m high (ground to tip), due to its scale and elevated location in this highly valued landscape would constitute a prominent and incongruous feature which would cause significant harm to the character and appearance of the landscape and associated visual amenity to an unacceptable degree, contrary to Policies ER2 and DM2 of the Copeland Local Plan 2013-2028, the guidance contained in the NPPF, the Ministerial Statement, June 2013 and Planning Practice Guidance on Renewable and Low carbon Energy, July 2013.

**4/13/2504/0F1** - Application for a New Two Storey Office Building with Associated Car Parking and Landscaping at Plot 7A, Crow Park Way, Westlakes Science & Technology Park, Moor Row,

**RESOLVED** – That the application be Approved subject to the amendment of the following condition:-

"Condition 6. Prior to first occupation of the building, a schedule of landscape maintenance shall be submitted to and approved in writing by the Local Planning Authority. The schedule shall include details for its implementation. Development shall be carried out in accordance with the approved schedule."
