Summary	Reports to the Working Party a request from the Sandwith Village Group for establishment of a standalone parish for Sandwith or Sandwith and Rottington
Recommendation:	That the Working Party considers whether the Council should commence a Community Governance Review as a result of the request from the Sandwith Village Group

1 INTRODUCTION

1.1 A letter has been received from the Secretary to the Sandwith Village Group expressing an interest in establishing a standalone parish for Sandwith or Sandwith and Rottington. An opinion survey has been carried out among residents which showed a 34% return rate and some interest in the potential for a parish council. The correspondence received is attached at Appendix "A" and the responses to the opinion survey will be available for inspection at the meeting.

2 BACKGROUND

2.1 A principal council (unitary county or district) has powers under Part 4 of the Local Government and Public Involvement in Health Act 2007 to undertake a Community Governance Review of all or part of its area, and to decide whether or not to implement the recommendations of such reviews.

2.2 A principal council is required to undertake a Community Governance Review if a public petition is received which triggers a review of the area concerned. A public petition is required to meet certain criteria – including a minimum number of signatures (depending on the number of electors in the area) and a definition of the area to which the review should relate.

2.3 A principal council has discretion to decide whether or not to undertake a Review in cases where the minimum criteria are not met. DCLG and the Electoral Commission have published guidance for principal councils on the conduct of Community Governance Reviews, which requires a principal council undertaking a review to draw up and publish terms of reference of the review. In addition the Guidance states, inter alia:



 2 of these indicated that they would like to be included in a South Whitehaven Parish
 2 indicated that Sandwith should not be included in any Parish
 2 indicated that they would prefer to be included in St Bees Parish
 1 indicated that they are happy to be in any Parish
 1 indicated that further funding information was required prior to a decision being made
 21 indicated that they would prefer to be included in a Sandwith Parish
 25 indicated that they would prefer to be included in a Sandwith/Rottington Parish
