SH 23 <u>Declarations of Personal and Prejudicial Interests</u>

Councillors Paul Whalley and Peter Stephenson declared a personal interest in the agenda item due to being tenants of a housing association.

SH 24 Tenancy Strategy and Affordable Rents

The Housing Services Manager introduced his report to the panel on the two issues of Social Housing Tenure in Copeland and Affordable Rents.

With regards Tenancy Strategy, it was outlined that the Government wished to end the virtual monopoly of lifetime security for new tenants (existing tenants being fully protected). Social landlords would then be empowered to grant fixed term tenancies.

The representatives of Impact Housing, Two Castles Housing and Home Group then provided the Panel with their plans for the future.

Impact Housing stated they had no clear strategy yet to respond to the new legislation and would not be introducing any changes from next April.

Two Castles Housing stated they will be continuing as now, with fully assured tenancies and would not be offering flexible

Home Group stated they would also be continuing as now with lifetime tenancies

The Panel moved on to discuss Affordable Rents.

At this point, the meeting divided into three groups where each of the Housing Associations had discussions with Members and Housing Officers in private.

Members and Officers then reconvened to share the information obtained in the three work groups.

Members were advised that the Tenancy Strategy would now be worked on by Housing Officers and a further report would be brought to a future meeting of this Panel.

It was requested that details of the shared knowledge be collated and shared with Members

Members wished to thank the Housing Associations for their input.

RESOLVED - That

- a) the Housing Associations be thanked for their input
- b) the Housing Strategy be worked on and brought to a future meeting
- c) details of the shared knowledge be collated and shared with Members.
