Summary and Recommendation:

Attached as Appendix 1 is a list of projects that must be completed before the Audit Commission re-inspect the Housing Service, most likely to occur in October 2009.

Members are requested to note the report and their comments are invited.

1 INTRODUCTION

- 1.1 At its meeting on 27 February 2009 the Panel considered a report describing feedback from the Audit Commission's 3 days consultancy at the end of January.
- 1.2 Members will recall that the Inspector identified 52 current strengths and 38 weaknesses. The former Strategic Housing Action Plan is renamed Improvement Plan and officers will address all remaining weaknesses.
- 1.3 Appendix 1 therefore comprises the residual improvement plan that must be completed to comply with the Audit Commission's recommendations in their original report published in 2008.

2 NEXT STEPS

- 2.1 Appendix 1 is also a list of projects with their target completion dates. For the more complex tasks involving partnerships, consultation and Council approval before implementation we shall produce project plans and report them to future meetings of the Panel.
- 2.2 Where the target completion date is later than the expected re-inspection (for example, the emerging Cumbria Choice Based Lettings Scheme), project plans will enable the inspectorate to assess the Council's "direction of travel" and therefore its prospects for improvement.

3 FINANCIAL AND HUMAN RESOURCES IMPLICATIONS (INCLUDING SOURCES OF FINANCE).

3.1 For 2009/2010 any financial implications can be met within existing resources. There are expected to be financial implications for Choice Based Lettings and a Cumbria-wide Housing Needs Survey in 2010/2011 but these will be the subject of consideration in the next budget building round.

4.1 This report and recommendations are in accordance with the Council's action plan following the Audit Commission's inspection report.
