Item 5 – Cleator Moor Town Deal Board

Draft Town Investment Plan – Section 2 context and emerging design

Why is this presentation being made to Cleator Moor Town Deal Board?

In October, Hatch Associates circulated a draft report outlining the Socio-Economic Narrative for Cleator Moor for comments and input from the Board. This has helped form the basis of Section 2 of the emerging Town Investment Plan. Hatch also presented design themes for the final production of the Town Investment Plan.

Section 2 of the Town Investment Plan captures the context and opportunities for investment, outlining the challenges that the Towns Fund will address. This is a presentation of the emerging draft of Section 2 for discussion.

The presentation will include an overview of the emerging design/ spatial plan for discussion.

Item 6 – Cleator Moor Town Deal Board Emerging Logic Model against project themes
