Item 5 – Cleator Moor Town Deal Board Programme Report March 2022

Why is this report coming to the Cleator Moor Town Deal Board?

The Programme Report provides Cleator Moor Town Deal Board with a regular update on progress being made against projects and programme. The template used has been provided by the Towns Fund Partner as part of the support to towns.

Item 6 – Cleator Moor Town Deal Board Phase 2 Business Case update

Why is this report coming to the Cleator Moor Town Deal Board?

Following the Heads of Terms offer from the Department of Levelling Up, Housing and Communities (DLUHC), Cleator Moor Town Deal moved into phase 2, business case development.

Cleator Moor Town Deal Board confirmed it was taking forward all five projects in its Town Investment Plan to develop HMT Green Book standard business cases to evidence the case for investment from government and partners.

Hatch have been retained to lead the Business Case development process – providing strategic and economic cases for all five projects and working with project owners and their technical teams each bringing forward the commercial, financial and management cases for each scheme.

The business cases are due for submission in March to Cumbria County Council for appraisal on behalf of Copeland Borough Council as Accountable Body to ensure that the required assurance on each project has been carried out prior to Business Case Summary submission to DLUHC in June.

Hatch will update the Board on Business Case progress, including remaining issues being addressed.

The next formal Cleator Moor Town Deal Board meeting will be held w/c 6th June 2022 to sign off the Business Cases prior to the Business Case Summary submission.
