EXECUTIVE SUMMARY

The Copeland Play Strategy Update builds upon the "Children's Outdoor Play Area & Teen Space Strategy for Copeland" adopted by Copeland Borough council in 2003 and relates directly to the Children Act 2004 and subsequent "Every Child Matters" policy for supporting the well being of children and young people. It establishes a partnership strategy covering the period 2007-2012 to advise and inform the provision of play for children and young people between 0-19 years of age ensuring that the needs of vound people are met in terms of facilities and accessibility. Development of this strategy update has taken into consideration changing policies both national and local and is assessed against local demographics and demands for services.

"We want children and young people in Copeland to be able to take part in and enjoy play in all its forms in their local communities. We will ensure that Children and Young people have access to a range of good quality facilities, opportunities and environments that stimulate free play."

Copeland Borough Council recognise that for the strategy recommendations to be

implemented a requirement to attract additional and alternative ways of funding play area provision will need to be developed. The Council will work with partner organisations to achieve this goal including utilisation of planning legislation and through designated funding streams such as the "Big Lottery" and wider regeneration and community funding opportunities.

The Strategy Update interprets the term 'play' in regard to all levels of activity that children and young people engage within for their enjoyment. This has been defined as:

- Physical play equipment/structures
- Communal open spaces
- Green spaces
- Play scheme provision
- Youth activity structures

Consultation has been undertaken at varying levels to produce this update Strategy incorporating stakeholders, the local community and children to ensure that a balanced and coordinated approach is ultimately delivered.

The Copeland Play Strategy Update is supported and endorsed by local support organisations and providers and complements strategic policies and approaches across the County as well as local Children and Play policies.

INTRODUCTION

3.1 Purpose and Scope

This strategy update has been produced in accordance with guidance notes produced by the 'Children's Play Guidance' – Planning for Play (Guidance on the development and Implementation of a Local Strategy) and supplements the existing Copeland Play Strategy 'Children's Outdoor Play Area & Teen Space Strategy for Copeland 2003-2008' by providing a review of current and future needs in light of changing national and international Children and Young People policies.

The strategy will complement the existing 'Children's Outdoor Play Area & Teen Space Strategy for Copeland' to achieve the agreed policy objectives as approved in 1995 as follows:

(a) the present policy of phasing out existing play areas as they became unsafe be extended and a long term programme devised to ensure that eventually all major areas with a concentrated population be served by a strategic play area, with particular emphasis on Wards identified as having the highest incidence of deprivation and in which a shortfall in play area provision can be demonstrated; (b) the phasing out of smaller play areas be continued as they became unsafe;

(c) major maintenance projects be funded as future Capital projects or a nonrecurring revenue bid;

(d) that responsibility for Parish Council play areas presently inspected and maintained by Copeland be reverted back to the respective Parish Council should unserviceable equipment not be replaced;

(e) support be given to Parish Councils in the form of advice regarding equipment conditions and purchases, and limited minor ground maintenance tasks on a one off basis by prior arrangement; and

(f) open sites, where appropriate, in or near housing estates be designated as open play areas in consultation with the relevant parties as outlined in the report

Based upon an audit of play provision throughout the borough, carried out in 1995, play areas were constructed in the subsequent 4 or 5 years in the areas of deprivation where a shortfall was identified.

A variation was made to the present policy in 2002 with a pilot project to enable the development of a play area on the Greenbank estate. The Greenbank Community Association in partnership with Groundwork West Cumbria obtained funding for this facility. The equipment belongs to the Community Association and they are responsible for the cost of insuring and maintaining it.

This pilot is a model to be followed for future Council/Community partnerships to meet local needs and fill gaps in the existing provision. Key to this type of development will be the formation of "Friends" groups willing to become actively involved in the improvement and management of local facilities.

This update will provide an updated breakdown of the population of children in the Borough on the basis of ward and age. It will support the future sustainability of the service and will form a framework for the allocation of resources and training. Through the implementation of the strategy the quality and safety of play areas will be improved.

The strategy update aims to ensure that a comprehensive structure is in place to advise and inform future play provision for the children and young people of Copeland Borough through provision of a range of facilities and services which strategically meet the aspirations of current and projected future demand.

The document is aimed to be used by a range of bodies involved with children and young people in facilitating play provision including statutory organisations, voluntary organisations, individuals or anyone who has an interest in ensuring that play provision services are developed strategically.

To advise and direct formulation of the Copeland Play Strategy Update 2007-21012 the following key processes have been undertaken:

- Formation of a 'Play Partnership' of key individuals, organisations and agencies be established. This has been undertaken within Copeland by the West Cumbria Local Planning Group for Children and Young People (Linked to the West Cumbria Strategic Partnership) who have taken on the role 'Play Partnership'.
- Review of existing National, Regional and Local policies and strategies have been undertaken to ensure co ordination.
- Baseline scoping of services have been undertaken including the following:

- Baseline audit of existing formal play provision
- Baseline Access audit
- Baseline audit of existing open play/green spaces

- provision Baseline audit of existing children services
- Analysis of existing children and young people demographics by locality/ward
- Review of existing community and parish plans to identify community issues for Children and Young people
- Consultation process undertaken with young people and local groups actively engaged within play
- Production of a Copeland Play Strategy Update
- Production of a detailed Action Plan

 Adoption of the Copeland Play Strategy as a revision to current Council policy

A primary aim of the Strategy Update is to support development and delivery of play provision which achieves the objectives of the "three Free's":

Free-no chargeFree-Children and young people
choose their play activityFree-Children and young people
choose to attend or not
(free choice)

3.2 Definition of Play

The Council' current strategy recognises play as fundamental to the life of every child; play is vital both to children's quality of life during their childhood, and to their development into healthy and independent adults. It is also therefore essential to the health of the wider society in which they live.

Adoption of the current strategy and the commitment of the Council to continue with a strategy for 2007-2012 reflects the Council's commitment to ensuring that children's and young people's wants and needs are central to the Council's delivery of services, and that provision is made to

meet those wants and needs. It seeks to improve children's lives by setting out the values and principles necessary to underpin a borough-wide Play Strategy for Copeland, which will set out proposals for the development of quality play opportunities and provision across the borough. Adopting the Copeland Play Strategy Update 2007-2012, and the commitment, contributes to the borough's Cultural and wider Community Strategies. It also takes account and coordinates with the Council's Corporate Plan 2007-2012 Vision, Values and Priorities. The strategy is founded on and supports the United Nations Convention on the Rights of the Child (ratified by the UK Government in December 1991), which recognises the significance and importance of play in children's lives.

Article 12 ' State parties shall ensure the child who is capable of forming his or her own views the right to express those views freely in all matters affecting the child, the views of the child being given due weight in accordance with the age and maturity of the child.'

Article 23 'State parties recognise that a mentally or physically disabled child should enjoy a decent life, in conditions which ensure dignity, promote self reliance and facilitate active participation in the community.' Article 31 ' State parties recognise the right of the child to rest and leisure, to engage in play and recreational activities appropriate to the age of the child and to participate freely in cultural life and the arts.' In the UK the child's right to play is articulated in the Charter for Children's Play, developed by the Children's Play Council.

We believe that:

- Play is fundamental to children's health and well being throughout their childhood and during their transition to adulthood. Children and young people engage in play for its own sake, not for any external goal or reward; it is a significant part of children's culture.
- Play is critically important to development children's and Children and young learning. people exhibit a behavioural imperative and instinctive desire to play. Through play children learn that which cannot be taught - that which can only be learnt through such selfexperience. as confidence and resilience. Α child's development, and their future capacity as an adult, will be affected by their access to a range of play opportunities.

- Play is a natural and universal activity. It is a process with no necessary outcome. Play is freely chosen (i.e. entered into by the child because (s)he wishes to do so); personally directed (i.e. under the control of the child playing); intrinsically motivated (i.e. is undertaken because it is satisfying for the child playing).
- Through play children and young people find out about themselves, their abilities and interests. Play therefore is one critical way children come to understand themselves and the world around them. Play helps children and young people to cope with difficult and stressful situations and fosters social inclusion.
- To support the child's right to participate fully in leisure, recreation and play the child's participation; opinions and views must be sought, listened to and taken into account.
- Risk-taking is an essential feature of children and young people's play; children and young people both need and want to take risks in order to explore limits, venture into

new experiences and develop their capacities.

We recognise that:

Children and young people want to play, and are entitled to do so, in a variety of public spaces near to their homes. This includes both places designated for play and shared public space.

The impact of modern, urban society on children's lives significantly restricts their opportunity to play freely, and has resulted in a poverty of play opportunities in the general environment.

Children, their families and society as a whole, benefit from an environment in which children and young people are able to play in public places free from unacceptable risks.

Designated play spaces can provide a range of play opportunities for children and young people beyond that which is available in public spaces.

Ensuring that all children and young people have access to stimulating and challenging play environments where they can take acceptable levels of risk, but where they are not exposed to unacceptable risks of death or serious injury, is an important objective of Copeland's play provision. (We support the policy statement 'Managing Risk in Play Provision', published by the Play Safety Forum and endorsed by the Health and Safety Executive).

Concerns about safety are increasingly presenting barriers. Fears of strangers and traffic represent the most significant risk issues identified by parents whilst it is recognised by children that bullying was also a significant issue. (Getting Serious About Play: A review of children's play 2004).

Some children, due to their personal or family circumstances, or their social and physical environment, have more limited access to play opportunities than others and the play needs of these children must be catered for in the development of this strategy. All play provision should reflect and meet the needs of the borough's diverse cultural community.

In adopting the Copeland Play Strategy Update 2007-2012 Copeland Borough Council will therefore:

Develop a comprehensive strategy, working across Council departments and in partnership with other statutory and voluntary agencies, to ensure that all children and young people within the borough have access to the broadest range of environments and opportunities to play.

And in doing so will:

- 1. Promote the importance of play to children's health and well-being, and to their learning, to all those working with children and to parents and carers.
- 2. Work to ensure that all parks, thoroughfares, housing estates and other public spaces within the borough are as conducive as possible to children's play.
- Develop and maintain a variety of local and accessible dedicated play and teen spaces. In doing so it will be guided by the 'Objectives for Play and Teen Provision' and the 'Criteria for an enriched play environment' identified in the document 'Best Play' (published by the Department of Culture Media and Sport by the National Playing Fields Association, Children's Play Council and Playlink; 1999).
- 4. Aim to offer all children and young people the chance to encounter acceptable risks in stimulating and

challenging play environments, free from unacceptable risk of serious injury or death. The benefits to children of exposure to acceptable levels of risk will inform the risk.

- 5. Work towards ensuring that a wider range of opportunities is available to disabled children and young people, and that all provision aims towards becoming fully inclusive and accessible.
- 6. Work to ensure that play providers actively seek to address the needs of children from "hard-to-reach" communities and those at risk from social exclusion.
- 7. Ensure that all our decisions and activities that might affect children and young people's opportunities and space to play should reflect this strategy.

COPELAND PLAY VISION

4.1 Vision of Play

"We want children and young people in Copeland to be able to take part in and enjoy play in all its forms in their local communities. We will ensure that Children and Young people have access to a range of good quality facilities, opportunities and environments that stimulate free play."

"Every Child Matters" identified five key outcome areas to support the development of play provision these outcomes being:

- Be healthy
- Stay safe
- Enjoy and Achieve
- Make a positive contribution
- Achieve Economic well being

The overall outcome of this strategy is to develop and direct activities that help achieve this goal and correlate with the activities of the Cumbria Children and Young Peoples Plan 2007-2010.

Being Healthy

Play is crucial to the health of babies, children and young people, contributing to social, physical, intellectual, cultural, emotional and psychological development.

Play provides opportunities to experience a range of emotions in a 'safe way' promoting resilience and self esteem.

Staying Safe

Play provision aims to manage the level of risk so that babies, children and young people are not exposed to unacceptable risks of death or serious injury; whilst allowing opportunities for babies, children and young people to be challenged and use their own initiative.

Play enables babies, children and young people to take risks, to think through decisions; gain increased self-confidence and greater resilience.

Enjoying and Achieving

The essence of play is enjoyment.

Play promotes a sense of achievement. When playing babies, children and young people define their own goals and interests, decide what is success or failure and pursue those goals in their own way.

Free play allows babies, children and young people a psychologically safe space in which to explore boundaries, try out new roles and experiences, be fully absorbed in what they are doing and to learn and grow as individuals and as members of a community.

Play allows for the development of problem solving, language and literacy skills as babies, children and young people develop their social skills and express their emotions. Play is also vital to the development of imagination, creativity interests and abilities.

Making a Positive Contribution

Good play provision should be "child led" and enable babies, children and young people to make decisions about their opportunities and environments.

Individuals and organisations are encouraged to involve babies, children and young people in play audits and discussions about their play and free time needs. Opportunities to make a positive contribution result in more appropriate provision, allows babies, children and young people to develop skills and knowledge, and ensures they are valued in the community.

Achieving Economic Well Being

Good play provision, which offers those seeking it, genuine challenge and excitement; can help bored children and young people behaving in ways that are socially unacceptable.

Good play provision enables parents/carers to work or train, thus bringing economic benefits.

Good play opportunities also encourages babies, children and young people to develop social and intellectual skills, that help them do better at school and can ultimately lead to greater employment opportunities.

4.2 Copeland Play Policies

Key policies have been developed to direct delivery and future development of play provision which impact directly upon the key outcomes identified through "Every Child Matters" as follows:

Play Policy 1: PROVIDE A STRATEGIC APPROACH TO PLAY PROVISION

<u>OUTCOME</u>:

Promote the importance of play to children's health and well-being, and to their learning, to all those working with children and to parents and carers. By linking the Play Strategy to wider local, regional and national strategies it will become an effective tool for providing good quality, appropriate play opportunities across Copeland and will help meet targets for other partners.

Emerging Actions:

- Ensure Play contributes to healthier communities by increasing provision in poor health areas
- Identify areas of need through statistics such as population densities, deprivation indices and geographical location
- Planning for play to be strategic rather than ad-hoc – provision is pro-active not reactive
- Concentrate on improvements to existing play sites
- Plan for revenue funding considerations/implications of outreach programmes
- Consider sustainability of

programme beyond lifetime of Lottery grant to ensure continuity of Free Play provision

- Link directly to Community Strategy and Parish Plans – Play Policy and Plan for the Babies, Children and Young People of Cumbria and Copeland Corporate Plan
- Ensure Copeland Play Partnership has good representation from Public, Private and Voluntary/Community sector organisations
- Action Plan to be agreed and delivered by multi-agency Play Partnership
- Ensure progress on Action Plan is monitored and reported back to relevant agencies
- Copeland Play Partnership governance to be linked to WCLSP (through Local Planning Group)

Play Policy 2: PROVIDE SAFE PLAY FOR ALL

OUTCOME:

Offer all children and young people the chance to encounter acceptable risks in stimulating and challenging play environments, free from unacceptable risk of serious injury or death. Work to ensure that all parks, thoroughfares, housing estates and other public spaces within the borough are as conducive as possible to children's play.

A range of safe play opportunities will be provided, which address the actual and perceived fears around personal and community safety, and meet the Safeguarding Children agenda.

Emerging actions:

- Invest in improvements to existing sites – lighting, landscaping, appropriate siting of equipment
- Ensure appropriate design and location of new play sites
- Work with Community Safety Partnership, Police/PCSO's, Youth Service and Schools to reduce opportunities for ASB/Bullying incidents (barriers to play)
- Support development of younger age groups to prevent ASB issues in the future
- Appropriate siting of play area's
- Monitor impact of improved play provision on Calls to Service and ASB incidents
- Involve and engage children and young people in the design and provision of play opportunities to ensure ownership and reduce the

likelihood of vandalism

- Be careful to manage expectations of children and young people, especially where there are issues around siting of facilities (teen shelters, skate parks)
- Provide training for volunteers in issues such as Child Protection, Health and Safety and First Aid

Play Policy 3: PROVIDE PLAY NEEDS ACCORDING TO AGE AND GENDER

OUTCOME:

Develop and maintain a variety of local and accessible dedicated play and teen spaces. In doing so it will be guided by the 'Objectives for Play and Teen Provision' and the 'Criteria for an enriched play environment' identified in the document 'Best Play' (published by the Department of Culture Media and Sport by the National Playing Fields Association, Children's Play Council and Playlink; 1999).

Play opportunities will be provided which are appropriate to and meet the different needs of children and young people of all ages, and the different requirements of girls and boys.

Emerging actions:

- Understand the different play needs of each age group through consultation and partnership working
- Ensure all ages are adequately catered for
- Provide more activities and venues for teens age group
- Support agencies in providing Youth Clubs/meeting places
- Mix of organised events to participate in and non-prescriptive places to 'hang out'
- Address parental concerns over safety; a barrier to free play for younger age groups
- Offer a range of activities for both genders to cater for different demands
- Provide outdoor play opportunities close to communities
- Work in partnership with other providers to increase access to free play opportunities
- Subsidised/free access to play schemes, youth clubs and organised activities

Play Policy 4: PROVIDE INCLUSIVE PLAY PROVISION

OUTCOME:

Work towards ensuring that a wider range of opportunities is available to disabled children and young people as well as children within low income families, and that all provision aims towards becoming fully inclusive and accessible.

Work to ensure that play providers actively seek to address the needs of children from "hard-to-reach" communities and those at risk from social exclusion.

To ensure that appropriate play opportunities are provided for children of and young people regardless of ability and that the needs of excluded, marginalised and hard-to-reach groups are met.

Emerging Actions:

- Work closely with disabled children and young people through formal or informal consultation to better understand their play needs
- Ensure new and existing play areas comply with DDA legislation
- Play areas to be accessible for all
- Consult and work with disabled user groups to develop play

opportunities

- Work with partners to engage hard to reach groups in planning for and providing play opportunities
- Work with excluded children and those at risk from harm who don't engage in mainstream provision to ensure their play needs are catered for
- Link with Health visitors and Sure start to educate parents in play
- Organise intergenerational projects to break down the barriers between young people and older people

Play Policy 5: MAXIMISE FUNDING OPPORTUNITIES

OUTCOME:

To work in partnership with public, private and voluntary/community sector organisations to secure external partnership funding for play provision.

Emerging actions:

- Link Play Strategy with PPG17 Action Plan to ensure maximum benefits from s106 funding
- Match-funding to be identified to ensure added value of Lottery bid
- Strategy to be driven by need rather than funding
- Members of Copeland Play

Partnership to identify possible sources of funding

- Partnership working to ensure a co-ordinated approach to funding
- Link strategy to other agendas to increase funding sources for play
- Support for partner organisations/agencies in applying for funding
- Copeland Play Strategy and statistical data to be available to partners making funding applications as evidence of need

Play Policy 6: PROVIDE VENUES FOR PLAY IN APPROPRIATE LOCATIONS OR COMMUNITIES

OUTCOME:

The necessary resources will be secured through partnership working to deliver quality play opportunities both indoors and outdoors to meet the play needs of children and young people.

Key actions within the policies identified which correlate with the five key outcomes of the Every Child Matters are identified as follows:

Emerging actions:

- Increase outdoor play provision
- Volunteer programme for workers
- Choose locations carefully
- Consult with users and neighbours
- Identify suitable indoor venues
- Schools extended schools and school grounds
- Community venues
- Consider accessibility issues
- Informal areas for play grass areas

CONTEXT

5.1 SOCIO/ECONOMIC PROFILE

Copeland Borough is located on the most westerly coast of the County of Cumbria and is one of six districts. The area encompasses both urban areas and rural which are partially within the Lake District National Park boundary.

The area has had a varied economic past and therefore the environment within the more urban areas have environments within which industrial development was once located but has now ceased due to economic restructuring. The opportunities for developing new economic infrastructure and environments to support diversification into new business sectors, including Tourism, are actively being pursued by the Council and its partners.

In spatial terms, two thirds of Copeland lies within the rural Lake District National Park. Population is concentrated in four main urban areas: Whitehaven, a Georgian town based historically on shipping and coal with a population of 25,082; and Cleator Moor, Egremont and Millom which developed through the existence of iron ore (now exhausted) with populations of approximately 7,000 each. The total population of the borough now stands at 69,318 based on Census 2001 data.

The largest urban area is the town of Whitehaven (consisting of 7 wards) which has a population of 25,082 based on Census 2001 data, the district is split into 17 wards in total.

Copeland witnessed a net population outflow of 2,100 residents from 1991 to 2001 (this was ranked 348 out of 376 LA districts in terms of net outflow, 376 being the highest outflow). Worryingly, the outflow (in relative terms) was concentrated amongst younger age cohorts.

The infrastructure servicing Copeland does present problems as both road and rail routes require improvements to ensure that a fully accessible public transport infrastructure can be catered for especially to the south of the borough. Copeland has a number of the natural assets that that are identified as being attractive in terms of individuals who intend to relocate from conurbations and city life to remote rural settings. These assets include a picturesque rural setting, low density of population and impressive coastline.

5.2 STRATEGIC POLICIES

Context

Copeland Play Strategy Update in association with the Original Strategy directly meets many of the aims and targets set out within other key strategy documents identified below. All relate directly to the needs identified by the local community through various consultation exercises.

Play in International context

The UN Convention on the Rights of the Child (1989) gives all children the right 'to rest and leisure'; to engage in age appropriate play and recreational activities'

Play in National context

Recent years have seen a growing interest in children and young peoples play and the need to improve this is now included in many government policies. Local Authorities in England have a statutory Duty placed upon them under the Children Act (2004) to co operate in their provision for the enjoyment of play and recreation as part of the five key outcomes for all children. Getting Serious about Play – A review of Children's Play

This report recommended that Local Authorities should be allocated resources based on child deprivation in their area, as well as requiring partnerships to be formed with local partners and interested stakeholders. The ultimate aim being to develop high quality projects which would meet the local community needs and which consider long term sustainability as part of the process.

Every Child Matters

In 2004 the Government produced the 'Children's Act' within which the 'Every Child Matters' Agenda was raised ('Every Child Matters: Change for Children' 2004), this document highlighted five key outcome for children and young people.

The Copeland Play Strategy Update is developed to help make a contribution to the Governments agenda by ensuring that the key outcomes are considered within the process of the emerging strategy, details are identified within section 4.1.

Planning for Play

Guidance on the production of Local Play Strategies was published by the Children's Play Council and the BIG Lottery Fund in April 2006. The Copeland Play Strategy Update has followed the process outlined within the guidance document 'Planning for Play'

Cleaner, Safer, Greener agenda

The Governments Department for Communities and Local Government has developed policy to support environmental improvements within deprived areas specifically relating to physical improvements and enhancing open environments for public use. South Whitehaven which encompasses the most deprived wards of Sandwith and Mirehouse is a focus for this activity and helps contribute to the overall aims of the Copeland Play Strategy update.

'Cleaner, safer and greener communities by improving the quality of planning, design, management and maintenance of public spaces and built environment'

With regard to parks and green open spaces it states that:

'Parks and green spaces have an essential role to play in building sustainable communities, enhancing people's quality of life in our towns and cities and contributing to the cleaner, safer, greener agenda' In regard to Parks and Open Spaces it states:

'Parks and Green spaces provide a wealth of opportunities for improving the quality of life for children and young people. Good quality spaces can provide opportunities for formal and informal play, exercise and learning. For the child this can help them make new friends, improve their self esteem and behaviour, keep them fit and healthy and encourage creative thinking and learning. It can also help to achieve wider social objectives to tackle childhood obesity, reduce health inequalities for those in the poorest communities, and encourage social interaction between children. As well as enclosed play areas, the range of green spaces form parks and gardens to woodlands and city farms provide creative play spaces for children and young people to explore and discover'.

Copeland Borough Council recognises the importance of its parks and open spaces in supporting free play. Consultations have revealed that this is supported and shared by the local communities that use them.

Neighbourhood Management

The government proposals to address the most deprived super output areas by providing Neighbourhood Management structures to help combat inequalities within health, crime, education, housing and the environment.

This initiative is also targeting the South Whitehaven area and helps contribute towards the overall ambitions to address the most deprived wards and to support improvements within the quality of life for residents, this correlates directly with the approach to enhance opportunities for young people to improve their health and wider social skills.

National Planning Guidance

This explicitly recognises the need for dedicated outdoor space for play and recreation. Planning Policy Guidance (PPG17) requires Local Authorities to assess the needs and opportunities for different types of open space and recreational facilities, including play space for children.

Links with other National Policy

There are a variety of accompanying policies which complement the Play agenda and are strongly linked to this

strategy, these are:

- The Extended Schools Initiative
- National Planning Policy Guidance Note 17 – Sport and Recreation (PPG17)
- The National Playing Fields Association – Six Acre Standard (2001) as detailed within Copeland's original strategy
- Transport strategies within the County
- Copeland Cultural Strategy

LOCAL STRATEGIES AND POLICIES

Strategic documents that provide a local structure for development and delivery of a Copeland Play Strategy are:

Copeland Local Plan – Recreation and Leisure

The government's Plan for Sport is a clear statement that sport has a major role to play in terms of quality of life objectives and in achieving a sustainable future. There are social, cultural and health dividends involved in the national programme assisted through Sport England initiatives which locally include the co-ordination of an Active Schools programme. the Cumbria Sports Partnership and most importantly a Sports Action Zone covering Copeland, Allerdale

and Barrow.

The Sports Action Zone Action Plan (2001 – 2006) and the Council's Cultural Strategy (September 2002) are the principal tools in delivering the government requirements at the Copeland level. The two involve targeting particular sections of the community (like the elderly, disabled and youth), and those wards scoring highest in terms of socio-economic deprivation and health problems.

The need is to increase the number, range and access to sports and informal recreation facilities and equally to coordinate delivery with Health Action Zone initiatives, community capacity - building, prevention/community crime safety and the schemes extension of employment opportunities through sport. Such an approach is encouraged though RPG Policy E C10 and JSP L57

Local plan policies can assist this process in assessing opportunities for sport and recreation provision, identifying suitable sites and safeguarding open space and its access from inappropriate development (PPG 17). Policy HSG 8 (5) is intended co-ordinate the provision of new open space as part of housing development in the plan area. The Tourism Opportunity sites (Policy TSM 2) may provide other opportunities for sports and recreational use by local people and similarly the proposed Action Plans for Whitehaven Pow Beck and Coastal Fringe area; Millom and Egremont (under the Market Towns programme); and work at Cleator Moor as part of the SRB programme will bring forward projects which combine tourism and local recreational benefits.

The use of urban fringe and non-sensitive coastal sites will feature in these initiatives together with the need for accessibility for all modes of transport. RPG Policy UR 12 and JSP Policy L58 help justify the notion of a Regional Park being developed in the Coastal Fringe area of Whitehaven.

The provision of open space and play areas is aimed at achieving the National Playing Fields Association standard of 2.4 ha per 1000 population.

The Council will carry out a full assessment of needs and opportunities of its green space, sport and recreation requirements in accordance with PPG17 as part of the Local Development Framework. Until this is done there is a need to retain all the existing open space, pitches and play areas. Policy ENV 9 commits the Council to the protection of areas of local landscape within settlement boundaries. There are also areas which are important as regards recreational utility and these have also been identified in terms of Policy SVC 13 which will be generally applied to prevent any diminution of existing provision.

Approval for development involving the loss of sites or facilities will not be given unless a satisfactory replacement is provided. This must be at least as equally accessible, should equal or better the site or facility in area and quality and should be suitable in terms of physical conditions e.g. topography, drainage. The sites protected by Policy SVC 13 include a wide variety of community facilities. Quite often they are on the edge of settlements. near open countryside where their contribution to landscape character is distinctly secondary to their recreational or other utility.

However, there are such sites which perform a dual role of providing utility and green/wildlife space breaking up an otherwise continuous urban form or which contribute an essential element to townscape or village character. These sites are identified on the Proposals Map under policy reference SVC13/ENV 9. Since their landscape significance is specific to location their suitability for options is restricted. replacement Replacement will only be considered as an option in exceptional circumstances which will include an assessment of landscape treatments for both the replaced and

replacement sites. As part of the scheduled Development Plan Document on open space and recreation the Council intends to identify all village greens or commons that merit protection and wherever appropriate to add these to the sites covered by Policy SVC 13.

Within settlement boundaries the Council will generally support proposals for new recreation and leisure development subject to the application of Policy DEV 5 and Policy DEV 6 (and the provisions of section 5.3 of the Plan) other policies in the Local Plan. A number of action programmes for economic regeneration are in place or are being developed in the Borough and the Council will give preference to projects which have a recreation or leisure dividend for the local community.

Some leisure uses, the most obvious of which are golf courses, require large areas of open land and care must be taken to ensure that new proposals do not compromise important landscape or conservation interests.

Accordingly, the Council will favour such uses on derelict land or urban fringe situations and will subject proposals for ancillary facilities and buildings to the requirements of Policy DEV 6. Other pursuits, notably motor sports, clay pigeon shooting and air sports may well give rise to noise or other disturbance and should avoid situations close to residential areas. Controls may need to be applied to the frequency of use and hours of operation and good screening will be required. When considering proposals for riding schools or livery stables the main concern will be to ensure that sufficient land and/or buildings are available for horse-riding. If it is intended to use bridleways in the locality contributions towards maintenance costs may be sought from developers. Contributions may also be sought to improve highway conditions in the vicinity of any subject site within the terms of Policy TSP 6.

POLICY SVC 14:

Outdoor Recreation and Leisure Facilities

Proposals for new or expanded outdoor recreation and leisure facilities will be permitted subject to the requirements of other plan policies and provided that the development would not:

1. be detrimental to the appearance of the local countryside or result in the loss of or harm to an area of landscape, wildlife or conservation importance

- 2. adversely affect the living conditions of local residents or those likely for occupiers of land allocated for residential development in the plan
- 3. create unacceptable traffic conditions in the vicinity of the site.

Copeland's countryside is of a very special quality. Two thirds of the Borough lies within the Lake District National Park (i.e. outside the plan area) and the marginal areas and sections of coast, including the St. Bees Head Heritage Coast, are of exceptional landscape value. There are also many areas of wildlife and conservation significance. Accessibility from the urban areas is relatively easy affording opportunities for walking, cycling, horse riding, picnicking and quiet enjoyment.

However, many leisure developments would be likely to destroy the very tranquillity which makes such areas attractive thus development in the best areas of countryside will be limited only to those facilities such as small car parks and public transport facilities, information panels, picnic areas and toilets which support low-key, informal recreation. POLICY SVC 15: Leisure and Sensitive Areas of Countryside

Proposals for small-scale leisure developments directly related to the quiet enjoyment of the countryside will be permitted within Areas of County Landscape Importance, the St. Bees Head Heritage Coast and Nature Reserves and adjoining SSSI's and other sites of conservation interest provided they are sensitively designed and sited and would cause no harm to the special character of the area.

Section 106 Agreements

Copeland Borough council recognises the opportunities provided to support play provision funded through Section 106 agreements and will endeavour to utilise this process to maximise investment into community projects which encourages and nurtures play. This external funding stream will be investigated where possible with any new developments being presented to the Council.

West Cumbria Strategic Partnership

The West Cumbria Strategic Partnership are currently finalising the 'Strategy for Sustainable Communities in West Cumbria 2007-2020' which identifies a sustainable vision for the development of communities.

The Vision is that by 2020:

'West Cumbria is a successful, confident place, with a diverse sustainable economy, built around its special landscape and seascape, and a reputation for innovation and excellence in developing technology."

To create communities that provide children and young people an environment that can enable them to thrive and develop the West Cumbria Strategic Partnership have identified the following objectives for the period up to 2020:

- Support Lifestyle Choice (Climate change and biodiversity)
- Encourage Coastal Renaissance (The spatial strategy)
- Making better connections (transport and communications)
- Communities that work (Social and economic inclusion)

 Quality public services (Service delivery within communities)

The Draft Strategy 2007-2020 makes specific reference to "We will provide high quality services to children and young people, to improve their life chances and well being"

Cumbria County council Play Policy 2007

Cumbria County council and the Districts have completed production of County Play Policy and been adopted in July 2007. The frameworks for the policy correlates directly with the key themes identified within the 'Every Child Matters' and therefore has a common approach to considering play and supporting children which is inherent within the emerging policies which are directed upon Copeland borough.

Its Mission statement is: 'Working in partnership across Cumbria, and reflecting the diversity of both urban and rural communities, we will aim to ensure that babies, children and young people have access to good quality play opportunities, activities and environments'

The adopted objectives are:

• To raise the profile of play

opportunities in Cumbria

- To meet the play needs of all babies, children and young people, including those who are disabled or have specific needs and wishes
- To recognise the fact that babies, children and young people need and want to take risks
- To recognise the importance of involving children and young people in decision making
- To encourage individuals and organisations to take an active interest In providing opportunities for play
- To encourage individuals and organisations to identify the impact their services have on play opportunities
- To support the provisions for play as outlined in the Children and Young Peoples plan 06/08
- To recognise the role of play within the Every Child Matters Framework

The Copeland Play Strategy Update recognises these principles as a fundamental direction for this strategy.

The Cumbria Children and Young People's Plan

The key strategic document which informs and advise overall services delivered within Copeland (Cumbria as a whole) is the 'Cumbria Children and Young People's Plan 2007-2010 – The best for every child, young person and family' this document establishes the framework for service delivery and advises the context of the Copeland Play Strategy Update.

Their vision and Mission statement is:

Cur Vision

The beal for every child, young person and their fundees. Enabling children and young people to stay cale, be healthy, unjoy and achieve, make a positive contribution and achieve economic availability.

Cur mission

- To prede opportunities for all children, wantig people and their families and those working with and for them to be actively revolution developing and participating in attributions services.
- To ford new ways of working and sharing available resources to rewel the needs of children, young people and their lumices at the earliest opportunity.
- To provide a world-class learning experience that implies every child and young person to achieve their All potential in We, in work and as a member of their community.
- To rived in a highly skilled and megnated workforce to develop the expectations of orbitrary young people and their families.
- To correction services to serve improved outcomes through evidence based practice for all dividual, young people and their families

Play is seen as a fundamental aspect to supporting the Cumbria Children and Young People's plan by the provision of play especially in helping achieve the five key outcomes of 'Every Child Matters' which is the framework of the plan.

Sure Start - Children's Centres

Sure Start Children's Centre's are places where children under 5 years old and their families can receive seamless holistic integrated services and information, and where they can access help from multidisciplinary teams of professionals. The Government is committed to delivering a Sure Start Children's Centre for every community by 2010.

These Centre's are at the heart of the Government's strategy to deliver better outcomes for children and families, building on successes of Sure Start local programmes, early excellence centre's and neighborhood nurseries and mainstreaming the lessons learned to extend the benefits to all families. They are also a vital part of the Government's 10 year childcare strategy to enable all families with children to have access to an affordable, flexible, high quality childcare place for their child.

Background

The Sure Start Children's Centre programme is based on the concept that providing integrated education, care, family support, health services and support with employment are key factors in determining good outcomes for children and their parents. The concept itself is not a new one, it is about building on existing good practice, rather than starting afresh. The model builds on principles developed, and lessons learned, through earlier Sure Start funded settings which are expected to become children's centres.

A significant number of families with young children already benefit from good quality integrated services. Sure Start Children's Centre's enhance these services and extend the benefits to more families bringing an integrated approach to service delivery to areas where it is most needed.

Within Copeland the Children's Centres are located in:

- Whitehaven Howgill Centre
- Cleator Moor Birks Road Centre
- Frizington Centre

These three centres are located to the north and centre of the borough and provide a range of services to support 0-5 within West Cumbria.

Extended School provision

Extended schools are at the heart of the delivery of Every Child Matters, improving outcomes and raising standards of achievement for children and young people. There are now over 5,000 schools offering the full range of extended services, with almost half of all schools well on their way to doing so. Within Copeland there are 4 specialist schools offering extended schools services these are located within Whitehaven, Egremont, and Millom.

Extended schools are a key vehicle for delivering the Government's objective of lifting children out of poverty and improving outcomes for them and their families.

There is now clear evidence that children's experiences greatly influence their outcomes and life chances in later life. In particular, educational attainment is a powerful route out of poverty and disadvantage.

Extended schools are a key way of delivering Every Child Matters outcomes, an extended school works with the local authority, local providers and other schools to provide access to a core offer of integrated services including:

- a varied range of activities including study support, sport and music clubs, combined with childcare in primary schools.
- parenting and family support; swift and easy access to targeted and specialist services;

 community access to facilities including adult and family learning, ICT and sports grounds.

These will often be provided beyond the school day but not necessarily by teachers or on the school site.

What are the benefits

There is evidence that extended services can help to:

- improve pupil attainment, selfconfidence, motivation and attendance;
- reduce exclusion rates;
- better enable teachers to focus on teaching and learning;
- enhance children's and families access to services.


In terms of Children's Play the Copeland Play Strategy Update will help foster links between play and the extended schools programme in Copeland through:

- Consulting with local schools in strategic development of play
- Involve local schools in the development of new play facilities within their communities
- Supporting local schools in the development of out of school

hours and school holiday play provision.

Copeland Borough Council Corporate Objectives (2007-2012)

Copeland Borough Council has agreed a Cooperate plan for the next five years its priorities being:



Within this context the Council aims to support a range of activities which encourage children and young people engagement and development of services. These relate directly to points 1.3 (Provision of Strategic policies), 2.2/2.4 (increased accessibility to facilities and services), 3.3/3.6 (provision of quality open space and free play environments). Green space and wider open play provision being fundamental to future objectives of the Council. This strategy will direct and influence future Council and partner resources and services to meet Children and Young people's aspirations

Parish Councils

The Parish Councils have their own responsibility for park and recreational maintenance and improvements; they also have powers to provide for children and young people within their communities and budgets.

Copeland Borough Council actively works in partnership with the Parish Councils to support parish initiatives. Free play provision is developed jointly with the parishes to meet emerging demands were possible although current demand outweighs resources.

REGENERATION PLANS

Local Regeneration Initiatives have been established to support wider regeneration goals within the local villages and towns the Copeland Play Strategy Update will assist the delivery of the goals specifically in relation to supporting children and Young people.

The key issues and objectives are summarised as follows:

Egremont Market Town Initiative

Objective 3:

To improve services for young people and increase their involvement in the work of the partnership

Like many places both urban and rural the issues surrounding young people are close to the top of the agenda for local residents. Young people are very visible on the streets of Egremont. In the mornings and lunchtimes of school days the town centre is used as a meeting point and for the purchase of food and drink. In the evening's groups of young people hang around preferred meeting points.

While during the day the school links are generally associated with litter, the evenings are associated with nuisance behaviour, vandalism and, increasingly, drug taking and alcohol. This has led to a fear of crime and an undermining of community safety that is not generally supported by the official crime statistics themselves. These problems both real and perceived exist despite a good provision of organised activities and pastimes in Egremont that are targeted at young people. The Youth Works initiative is expected to kick-start a fresh approach to managing the problem.

The action plan proposes to tackle these issues in the following ways:

Creating space and place

For some young people the organised and supervised activities available through the normal channels of provision do not have an appeal. Regardless of their quality or availability they will not choose to participate. By providing facilities and opportunities for activity that is perceived as "unsupervised it is hoped to both alleviate and manage more effectively some of the current difficulties. By encouraging ownership of the projects it is also hoped to increase engagement with young people at the same time.

Coordination and management

Services for young people are spread across a wide range of agencies including leisure, youth services and social and health services as well as specific initiatives such as Youth Work. As part of a concerted effort to address some of the issues facing young people in a coordinated way it is proposed to establish a coherent strategy for young people's services by bringing the agencies together. It is recognised that this may need to be developed over a wider area than Egremont and its surrounds though it is essential that the strategy is flexible and responsive to local conditions in the town.

Engaging young people

Engaging young people in the discussions about the future of the town is always difficult. To recognise and address the aspirations of young people and to ensure that the town meets their needs into the future requires a better engagement of young people to enable their views to be articulated. Proposals to achieve this include working directly with the schools and the formation of a youth group as part of the regeneration partnership.

Millom Market Town Initiative

Objective 5

To support improved services for young people

The community of Millom and the surrounding area is fiercely independent and over time has drawn strength from the challenges it has faced. To support long-term development of the town it is necessary to harness that strength and energy and use it for the development of services and to contribute to long-term prosperity for the residents to support.

Play space for young people indoors Community childcare

Millom, like other small towns, is uncertain and unnerved by the behaviour of some of its young people. Despite a wide range of organised activities the culture of hanging about, vandalism and nuisance behaviour is identified as a problem. It contributes to a general fear of crime and is often associated, rightly or wrongly, with drug and alcohol misuse.

To help engage better with young people in the town it is proposed to improve the availability of space and places that young people can use in a largely unsupervised way and over which they can generate some ownership.

Services for young people

Engaging young people more effectively in the town and managing their needs more effectively.

South Whitehaven Neighbourhood Management

To enhance the quality of life and liveability of residents within the South Whitehaven neighbourhoods through directing of services to meet their needs and aspirations.

The objectives of the Neighbourhood Management programme are to provide a neighbourhood focus for all service delivery in the South Whitehaven area incorporating the neighbourhoods of Greenbank, Woodhouse, Kells, Mirehouse and Hensingham. This will result in service providers responding effectively to local need and will also encourage a joined up approach to the provision of services now and into the future.

The outcomes that the programme will bring about will be an improvement in the quality of life for local people and improving the attractiveness of the area as a place to live and work for existing families and for future generations.

The South Whitehaven proposals detailed within this document will work towards achieving the Governments "Respect Action Plan" through supporting the key areas of:

Activities for Children and Young
 People

- Schools Improving behaviour and attendance
- Supporting families
- Strengthening communities
- Effective enforcement and community justice

Green Space Strategy 2007-2012

Copeland Borough council's Green Space Strategy identifies all open land, natural or artificial, for recreation and nature conservation, including publicly owned or maintained land for public use by the Borough council. Key issues identified by Children and Young people include:

Younger children see green spaces as places to meet friends and enjoy exercise and games. They would like to see a full range of activities. They dislike the removal of play equipment because it is not always replaced. Older children want somewhere to meet in peace, enjoy activities such as basketball. skateboarding and tennis and to do so with a similar crowd. Less importance was placed on features such as flowerbeds. Facilities such as cable runways, basketball hoops, water features and skateboarding parks were most popular. They would also like activities and facilities for different ages to be separate.

The Green Play Strategy build upon play facilities for age groups in excess of 19 by supporting the concept of Green Gyms and the use of natural open spaces to support older age groups.

Cultural strategy

Copeland Borough Council agreed 'A Culture for Change Strategy' in 2002 to advise future culture developments within the borough.

The vision of ' A Culture Change' is:

'A borough where cultural activity is recognised as having a central place in the community, contributes to quality of life, and helps to address local identified priorities; cultural activity provides the opportunity for development and improvement, through partnership, communication and a shared agenda for change for the benefit of the people.'

Within the strategy a key consideration for change is to support 'Play' and to ensure optimisation of existing assets both open space and the hierarchy of play provision to support cultural development.

This strategy supports the strategic utilisation of open green spaces as a focus

for cultural use and play development.

Sports plan

To advise and develop the sports provision and to engage Children and Young people in health activities Copeland Borough Council adopted a Borough Sports Plan in 2002 to advise and direct future sports play provision.

It is recognised within the Plan that there is little co-ordination between agencies delivering activities for young people, especially during school holidays with no agency or partnership taking overall lead responsibility.

This strategy and the formation of the Play Partnership role through the Local Planning Group will direct activities which will help support ongoing co-ordination whilst ensuring adequate play provision is available during summer period and school holidays.

COMMUNITY ENGAGEMENT/CONSULTATION

6.1 APPROACH UNDERTAKEN

This section of the strategy outlines the consultation processes and mapping system that have been conducted in the Copeland Borough regarding open spaces and play opportunities and identification of community needs and aspirations as seen through the eyes of children and young people and their families.

The consultation process has been undertaken to ensure the views of young people are heard and that it is undertaken in an inclusive manner.

Methods utilised are varied to ensure that the widest approach and views are registered.

The consultation process utilised analysis of previous consultation exercises with Children and Young People through a desktop review in addition new surveys and research was undertaken which incorporated the following approaches:

 Surveys and questionnaires to young people (surveys forms distributed to a variety of Children and Young People across the borough)

- Face to face interactive approaches (Sure start engagement through play scheme, and Copeland play schemes)
- Focus Group engagement (Key youth groups engaged within local communities)
- Community led consultation (Engagement with parish councils, borough and County Council and through Regeneration Partnerships)

Youth Council survey

The Youth Council for the Borough was utilised to obtain their views on the key issues that they felt needed to direct future policy and the Schools were also invited to respond to the emerging play policies.

Nine schools were represented at the July 2007 Youth Council meeting (7 Junior and 2 Secondary – 32 children were present) that reviewed the Play Policies and the results were that the main 4 priorities for consideration were in order of priority:

- 1. Provide more safe and secure places outside to hang out and meet friends e.g. Youth shelters
- 2. Provide Multi Use Games Areas (for informal play)

- Provide more traditional play areas (swings, slides, climbing frames etc)
- 4. Provide more wheeled sports facilities skateboarding, roller blading, BMX etc

This information has helped formulate the strategy development and subsequent Big Lottery application.

Community Youth Group

Main Community Youth Groups were invited to respond to the emerging policy and to obtain views from children that access the current provision.

The groups that chose to engage within this process were:

- Harbour Youth Project (Whitehaven)
- Phoenix Youth project (Cleator Moor)
- Egremont play group (Egremont)
- Distington Club for Young People
- Sure Start Programme

Summer Activity sessions

In addition to engaging children and young people comments through community

youth groups Copeland Borough Council and Sure start utilised their summer play events and activities to engage children, a total of 153 children were engaged through this process covering a range of children from the borough.

This process is continuing during the remainder of the summer period but the initial results identified mirror the wider stakeholder and group's issues.

The results are representative of the sample of children taking part within the survey and it is acknowledged that a bias may be presented due to the sample size but through wider engagement with stakeholders it is recognised that the results are comparable with issues raised through other consultative exercises undertaken:

49% of respondents would like to see additional or improved wheeled sports facilities and informal kick around areas whilst 44% expressed the view for additional new MUGA facilities specifically within areas experiencing teen and youth issues i.e. Cleator Moor, Hensingham and Rural areas.

37% of respondents felt that maintained and improved local play sites would meet current demands of junior and toddlers. 7% identify social issues such as Anti social behaviour and bullying as an issue.

Play services were identified as being used by the local communities although it was felt by a significant number of stakeholders and children that improvements to rural services were needed. Awareness of activities and services was raised as an issue by 20% of respondents who believed that they were unaware of what was happening within their areas.

To combat this a number of stakeholders and groups have requested information being available to advise on activities available this would be beneficial to all children and young people.

Community led consultation

Consultation exercises were also reviewed that had been undertaken with local communities through regeneration partnerships. E.g. North East Copeland Regeneration Partnership, Egremont and Area Market Town Partnership, Millom and Haverigg Market Town Partnership (as detailed in section 5.2 Regeneration). Individual projects identified through community and neighbourhoods also advised and informed local issues.

Internal Consultation

Consultation with internal officers and members has been undertaken through a variety of approaches. The planning and Regeneration department have been engaged during the PPG17 policy evaluation and the Leisure, Culture and Parks department through corporate team engagement in the Executive decision making process for the policy.

Departments have been actively engaged in developing the strategy and through consultation exercises undertaken to inform the action plan.

Parish Plans

The following highlights the key issues raised by parishes in relation to play in Copeland.

Distington Parish Plan 2005

Engagement with Children and Young People in Distington was undertaken through the Community School and the Club for Young People.

The greatest request was for the Millennium Park to be upgraded and sorted out followed closely with a large percentage of those questioned putting the need for a skate-boarding and rollerblading park.

There were also requests for a swimming pool, improvements to the play areas, bike-park, a caravan site, and more places to play football.

Indoor activities were also high on the list of requests with a gymnasium, indoor soccer, a cinema, a new building for the Club for Young People, a museum, and somewhere older kids can congregate where they are not considered a nuisance to others.

On the subject of what was already good about the Parish the Club for Young People came out on top, while the cycle path and being close to the countryside were seen as plusses for the Parish. One reply stated that Distington is a friendly place and everyone seems to get on.

To obtain the views of the teenagers in the Parish, a small group of that age were given training in 'one to one' interviewing and then given the task of going out into the Parish to talk to their own age group to collect the required information. By using this approach, two objectives were achieved, as the training given to the young people to go out and conduct the interviews gained them vital experience that will serve them well in the future, while it was obvious that other teenagers were more forthcoming with their ideas to others of their own age group.

The older youth's replies regarding facilities within the Parish, mainly followed the same line as the school children, with the emphasis being on freedom to do their own thing without interference from adults.

Haile and Wilton Parish Plan 2004

Consultations were undertaken with a range of people within the parish in 2004-2005 (115 households). Results for the 5 to 10 year olds were that there was an expectation for them to have more freedom to play within the villages and experience wider play opportunities.

The 10 to 16 year olds have expressed an interest in a youth club which can be readily accessed as well as improved playing field and equipment.

Lamplugh Parish Plan 2002

A consultation exercise was undertaken in 2002 which obtained results form 53 under 18 year olds.

The results of the consultation identified that play provision is limited within the area although there are a number of facilities which support the older age group (Kart stadium, cycling on cycleway). There was a recognition that certain services and play provision would be catered for outside of the parish. In order to ensure access is available to the wider services transport was considered a major point for children and young people.

Weddicar Parish Plan 2005

Key issues identified through the consultation process identified that a lack of youth activities were recognised as a key issue for the parish although access to children facilities and youth activities in Cleator Moor were deemed to be within reasonable access through public transport infrastructure.

Arlecdon and Frizington Parish Plan 2005

Following a participatory appraisal undertaken by the local parish a number of key issues were identified relating to children and young people regarding free play.

There was recognition that there was a lack of things for young people to do, most young people hang out in the street or at friends. 55% are involved in sports clubs and team activities; 45% are already involved in youth clubs and 30% are involved in uniformed groups such as guides, scouts etc.

The provision of a youth club or centre are seen as a strong issue for the children.

Howgate Ward Plan 2003

A specific Youth survey was commissioned to engage with the 13-19 year olds within the ward 183 youths responded to the survey process.

Access to facilities within Whitehaven was deemed to be close enough to utilise although private transport was seen as the main mode of transport to these facilities. Within the locality the environment was deemed to be the main facility to support play both the open spaces and local play facilities although limited.

Youth facilities and youth club provision were seen as an area for further development to complement the existing local environment.

Cleator Moor Parish Plan 2005

A participatory approach was undertaken with the residents of Cleator Moor Parish in total 649 people were consulted of which 120 were under the age of 11 and 102 were between the ages of 12-16.

The lack of things for young people was identified as a key issue that caused most

concern for residents and children in Cleator Moor.

A number of youth related services and activities are developed in Cleator Moor although there is still a requirement identified for teen facilities to support and nurture further play provision outside of the formal youth club and sport activities.

Ennerdale and Kinniside Parish Plan2004

Consultation was undertaken in 2002 and 2003 which led to the formation of the Parish Plan.

It is recognised that play provision is supported through the Ennerdale Community Recreational Park and an array of sports related activities which are within close proximity. It is recognised that wider youth activities would be of benefit to support the existing provision. Access to wider facilities in Cleator Moor or the more urban areas was raised as a concern for young people; public transport is not good within the more rural areas.

Mapping exercise

As part of the process to identify a comprehensive strategy a comprehensive desk top audit has been undertaken within the borough to inform the level and quality of play provision, this information updates and complements the previous information identified within the Copeland Children's outdoor play area and teen space provision strategy by identifying play sites in relation to travel distance as recommended by NPFA guidance.

The approach undertaken to assess the facilities available were classified within the context of proximity to high population concentrations, the issue of Copeland

being a large geographical area has focussed the map data included in Appendix 3 to focus on the major populated areas within the borough and sites for proposed new facilities to be delivered through the Big Lottery funding, the map data identifies:

- Play facilities located within main population localities
- Sites for proposed Big Lottery projects

The results of which are detailed within appendix 3 which complement the audit detail of play services detailed in appendix 2..

6.2 RESULTS

The consultation and mapping process identified a range of issues which Children and Young People have identified.

Key findings

The key findings from the consultation process with stakeholders and Children and Young People are as follows:

Play Facilities

 The audit and mapping exercise identified widespread provision of traditionally equipped play areas with the majority being located within the most populated areas (Appendix 2 – Formal play provision audit).

- There is already a high provision of green and open spaces available within the borough to support informal play (Appendix 2 – Open spaces audit).
- Playing fields and recreational grounds owned and managed by the Council are fully accessible and freely available to all children and young people (Appendix 2 – Open spaces audit).
- Copeland has 3 sites with Heritage Green Flag and 4 sites with Green flag recognition (St Nicolas Gardens, Trinity Gardens, Egremont Castle, Distington Hall Crematorium and Walled Garden)
- A number of parish and community managed play equipped sites are located within the rural areas and are fully accessible to communities.
- Multi Use Games Areas are not provided sufficiently within the central area of the borough to support deprived and rural communities (gaps identified are in Gosforth/Seascale area, Cleator Moor to ensure strategic sitting of facilities)

- There is an increasing demand for youth shelters through out the borough but predominantly the demand seems greatest within the deprived communities with the highest children and young people population.
- Skate parks are located within Whitehaven and Egremont although additional challenging activities have been requested within both rural and urban areas.
- Copeland has a strong cycleway infrastructure which predominantly services the north of the borough; potential for further development has been raised for the south.
- Opportunities for new and enhanced play opportunities should be developed within deprived areas which exhibit high population in terms of children and young people (Hensingham has been identified as a key area for play provision).
- A more challenging environment in both play equipment and facilities has been identified specifically for the older teens (11-19). Seascale is a potential strategic site for a new challenging experience for young children located centrally within the borough.

Play Services

- A range of summer play schemes and activities are held each year and mostly located within the north and south of the borough. The most deprived communities have access to the summer activities although the rural communities have limited access. Additional outreach schemes should be considered to support rural communities.
- A Comprehensive programme of sport activities and events are undertaken during the summer holidays.
- Existing out of school and pre school provision is well serviced within the borough (Appendix 2 – Play service provision audit).
- Extended schools programmes are in existence through out the borough although opportunities for further development should be considered.

Specific issues

- Lack of knowledge and awareness of play activities/services available
- Improved access arrangements for rural areas were possible
- Safe environments for play which restrict/remove potential for bullying

EXISITING PROVISION

7.1 Audit of existing play provision and resources

A thorough audit of facilities and services available and supported by Copeland has been undertaken and mapped against population's settlements.

Appendix 2 provides detailed assessment of the existing provision for the following areas:

- Formal Play Provision
- Children and Young People population
- Play service provision
- Open spaces provision

Formal Play Provision

Appendix 2 details the sites of formal play provision linked to each ward/parish in total the number of formal play provision areas which the council provides some form of support total 50. The majority of formal play areas are located within the most populated areas of the borough although there is a significant number servicing rural communities (Whitehaven 9 sites, Cleator Moor 4 sites, Egremont 4 sites, Millom 3 sites).

Whitehaven

Whitehaven is the main populated centre of Copeland and incorporates the highest number of children and young people as well as the most deprived wards. A number of fixed play equipment is provided within the wards of Whitehaven directly through Copeland Borough Council and through partnering arrangements with local community groups and Copeland Homes Housing Association.

The majority of sites are deemed strategic sites (Bransty, Castle Park, Kells, Mirehouse west, Sandwith) and provide a range of equipment for junior and toddler age groups. All of the strategic sites are well used by the local communities. The remaining play sites (Harbour, Hillcrest and Mirehouse East) vary in the level of equipment and quality of provision but provide a service to the local communities.

The sites located in Woodhouse and Greenbank are owned by Copeland Homes Housing Association and provide facilities to the social housing estates within the most deprived ward. A gap in provision has been identified for the Hensingham ward as the nearest play provision is located within Hillcrest. Youth facilities are limited within Whitehaven in terms of MUGAs (Multiple Use Games Areas) and youth shelters; this is mirrored through out the borough.

Cleator Moor

Cleator Moor has a reasonable provision of play facilities with a good strategic play area being located on Jacktrees road but with limited provision within the south of the town. The sites are controlled and managed by the Town council and Borough council predominantly.

Robert Owens Close has been identified as a potential site for play development and is currently being developed by the local community to support provision of a MUGA. Smaller sites are located at Mill Hill, Cleator and St Johns Close (limited facilities provided by Copeland Homes) future consideration on the rationalisation of sites should be considered as part of any strategic development.

The lack of youth facilities is recognised as a key issue within Cleator Moor and it is hoped that the provision of a new MUGA will help support this.

Egremont

Egremont and area play provision is provided fully by Copeland Borough council through the Egremont strategic site located at Orgill and a further site located at Ling road. Provision of play equipment to a lesser standard is provided within two of the rural villages located on the outskirts of Egremont (Bigrigg, Moor Row). A lack of youth facilities is recognised within Egremont.

Millom

Millom Park located in the heart of Millom Town is a strategic site providing a good resource for the children and young people of Millom. The site is well managed and is a focal point for play activities within the town. A play site is located at Haverigg Pleasure Ground which is managed by the Town council which provides a range of equipment for junior children and toddlers.

Additional sites with lesser equipment are located at the Green, Village Green both managed by Village Hall Committees and in need of investment. Youth play provision exists within Millom although this needs to be supported by wider play service provision.

Distington

Distington has a strategic play area located on Barfs road which is owned by Home Housing Association but managed by Copeland and the Parish Council, a further site is located on Hinnings Road of a lesser quality and equipment. Pica village located on the outskirts of Distington has play equipment for junior and toddlers although with less equipment. Youth provision for Distington is recognised as an issue within the town.

Rural villages

Most of the rural areas have developed play provision through the proactive approach of the Parish Councils working the Borough council to provide play facilities within their own communities. With limited resources villages such as Gosforth, Kirkland, Ravenglass and Seascale have provided limited play provision to meet community needs.

The majority of rural areas and villages have provision of some form of play facilities although there is a gap within the more rural areas within the centre of the borough located around Drigg/Carleton, Irton and Santon and Nether Wasdale and Ulpha/Waberthwaite.

The play facilities developed are linked mostly to existing village greens and other

open spaces development within the villages which act as a focus for village life.

Copeland Borough Council recognise the importance of Parish Councils and community activists in supporting the development of play provision and will continue to direct and advise on funding and management issues.

A desktop audit has been undertaken of the sites within the borough and these have been used to map current play provision in Copeland, details of which are located in Appendix 2.

Children and Young People population

Analysis of the population data has revealed that the wards which contain the greatest number of children and young people mirror largely the ranking of wards within the Index of Multiple deprivation these being:

Mirehouse Bransty Egremont North Cleator Moor North Hensingham Distington Newtown Egremont South Harbour Sandwith (Frizington, Kells and Cleator Moor South being the exception – Detailed in Appendix 4)

Play services

Play services within Copeland are well established and supported across the borough (as detailed in Appendix 2) overall coverage of provision is less well developed within the centre of Copeland and could be developed further within rural area support.

Open spaces

Open spaces provision to support natural play is well catered for within Copeland through strategic managed sites and informal open space development within both urban and rural areas (as detailed in Appendix 2).

Recommendations

Review of the play provision within Copeland has identified that the main aspect to be considered is in terms of the quality of the provision rather than the quantity. Existing sites have a range of quality of play equipment which are being periodically upgraded within existing resources available or through securing of external funding working in partnership with community groups.

Open spaces and the opportunities for natural play are well supported by the provision of the green open spaces and urban fringe spaces.

Play services are well established through out the borough although there are some rural areas that require further support in providing initiatives to support teen services such as youth clubs and out of school provision as well as formal play provision areas.

Children and Young People population based on Census 2001 data identifies a ranking based on numbers of children versus IMD deprivation there is a correlation with the majority of wards as indicated in Appendix 2 and this fits strongly with the level of provision that is currently in place although a gap at Hensingham has been identified.

MONITORING/EVALUATION PROCESS

8.1 Methodology

The Copeland Play Strategy Update has been developed in conjunction with the Copeland Play Partnership. The lead organisation in terms of the strategy is Copeland Borough council Parks and Open Spaces Department.

A requirement of the strategy is to monitor the implementation and progress of the action plan, the process developed to facilitate this incorporates the following key aspects:

- Strategy Group meetings
- Parks and Open Spaces management meetings
- Performance monitoring as part of regular assessment process

The process utilised will review the key objectives and actions detailed within the agreed action plan and update and review as required over the life time of the strategy.

The Copeland Play Partnership is an established group which will meet on a regular basis (monthly) and will have strategic oversight of the plan and will

review overall performance, a formal review will take place at monthly intervals.

Progress of the plan will be monitored through the corporate plan process of Copeland Borough council.

The overview and Scrutiny committee for the Community will have a direct role to ensure services and deliveries of activities are coordinated, regular updates will be provided to the committee.

The Copeland Play Strategy Update is a working document and therefore it will be continually updated over time. After three years it is expected that there will be a full review which will ensure an evaluation has been undertaken to inform future action plans.

The evaluation process will compare what existed in 2007 as the baseline and assess the situation against future year's assessments. Data that is collected by the monitoring process will be collated and used to provide information on how well resources are being utilised to create the aims of the strategy.

Annual evaluations will be linked to reviews of the strategy.

Key indicators to be monitored will include surveys of communities' views on facilities and access to them.

Further detail is provided in the monitoring and evaluation table in the action plan.

- 8. To ensure that work is informed by children, young people and their families, and to coordinate participation, within the context of the countrywide strategy for engagement.
- 9. To co-ordinate and deliver the Cumbria Local Agreement in relation to Children's Services, and to contribute to other blocks as appropriate.
