

The location is totally unsuitable. The access, down a narrow lane, is not suitable for the increased amount of cars / vans that will be accessing and egressing the proposed site. The cross roads at the hospital Road has had 5 serious accidents in the last 5 years. Local amenities can not support another 24 families, I recently phoned for an ambulance for my sick mother and was told if I could not take her to the hospital myself it would be a 7 hour wait for an ambulance. Why are you proposing a site that will be built on contaminated ground? I remember this area was a tip when I was a child. You just have to look at the lane to Sneckyeat Farm to see that the run off water from this area is always rusty coloured and has oil 'rainbows' whenever it flows accross the road. I would like to express my objection to the proposed gypsey/traveller site at Sneckyeat Whitehaven.

First of all, I would like to express my disappointment at the absence of Mike Starky or a council deputy at the meeting held at Copeland athletic stadium on Thursday 18th August despite numerous requests for a council official to attend.

With regard to my objection, I wish to raise concerns on the suitability of the proposed site due to previous use as a dump for Albright and Wilson. I worked at Marchon for over 10 years and was part of the site demolition project over 15 years ago.

I am aware/experienced in the dangers of the chemicals processed on the site, and feel it would be harmful to the local population to disturb unknown quantities and toxicities of these chemicals, both airborne and through local watercourses while remediation of the proposed site is undertaken.

I would also like to voice my concerns regarding the Sneckyeat business park, after attending the meeting at the Copeland sports stadium several businesses voiced their intention to leave the business park if the proposed traveller site went ahead.

This would not only signal a loss of jobs and income for the local community, but in my opinion start a domino effect of other businesses leaving. If the proposed traveller site is given the go ahead it will discourage other businesses from the vacant premises.

Once the owners of the industrial estate fail to break even through the cost of extra Security measures and rent losses, they will simply close the site resulting in more job losses and lost income for the local economy. Are the council so short sighted that they can't see this?.

I attended a meeting last Thursday evening at the Copeland Athletics Stadium which was organised to discuss the proposed Gypsy site at Sneckyeat. However, I was really shocked to find that in spite of a number of requests, not one single member of the council turned up to listen to any concerns or objections that the local residents and attendees had, or to answer any questions or discuss any issues.

This was supposed to be the Consultation Period but there was no-one to consult with and no-one to address our concerns. Surely the council, elected by the local population, should be acting on our behalf and listening to our views too, not just considering the needs of the gypsies.

As the owner of the longest running business on the Sneckyeat Industrial Estate (almost 40 years) I feel I ought to be given the right to voice my opinion have my views heard.

I strongly object to the siting of this Gypsy site in the most densely populated area of Copeland, sandwiched between a large residential housing estate and an Industrial Estate. Surely a more rural site would be more suitable and more desirable to both the Gypsy population and also to local residents and businesses alike.

This proposed site is a former landfill site and we have been advised that hazardous material has been dumped there in the past. This could present problems with health issues to the Gypsy community who already suffer with more health issues due to their lifestyle choices than the majority of the population.

The proposed access to the site is directly through the middle of the small industrial estate and then up a narrow lane opposite the hospital staff car park. The nature of the Gypsy life is that they are travelling folk so there would constantly be movement of large caravans etc in and out of the Industrial Estate with the potential of blocking roads on the estate and causing accidents. There have already been numerous accidents at the egress point from the Industrial estate onto Homewood Road.

I would like to have the opportunity to raise more questions and therefore request an extension to the Consultation Period to allow for the general public to actually be able to consult with members of the council and get all the different issues addressed.

A lot of our members live on the estate and worry about their properties. We as a committee worry about our club, we don't have the money to install CCTV so our hut is a target. We don't keep much of any value in our club but that would not stop any one from breaking in. Talking to our members they remember the quarry being filled in with anything and everything. We wonder if a proper and full survey has been done before this sight was put forward.
