5. Millom Town Deal - Local Assurance Framework

Sarah raised that Pauline Preston in reviewing the document had queried the wording on the health representative as the ICC is not a legal entity and therefore should just reference a public sector representative.

Councillor Doug Wilson referred to the 'Conflict of Interest' paragraph and felt it was inaccurate to suggest that the Town Deal Board did not have decision making responsibilities. It was proposed that the word 'final' be inserted in that sentence.

RESOLVED: – That, with a unanimous vote for, the Millom Town Deal Board Terms of Reference be agreed subject to the change of wording on the health

representative and the amendment of the first sentence in the Conflict of Interest paragraph to read:

"Although the Town Deal Board does not have final decision making responsibilities, it does have significant responsibility in that it is an advisory body to Copeland Borough Council as Lead Council."
