#### **STATEMENT ABOUT RELEVANT CONVICTIONS**

When submitting an application for a licence to drive a Private Hire vehicle you are requested to declare any convictions or cautions you may have, including those regarded as "spent" under the Rehabilitation of Offenders Act 1974. The information you will give will be treated in confidence and will only be taken into account in relation to your application.

You should be aware that the Council is empowered in law to check with the Disclosure and Barring Service for the existence and content of any criminal record held in the name of the applicant. Information received from the Disclosure and Barring Service will be kept in strict confidence while the licensing process takes its course and will be retained for no longer than is necessary.

The disclosure of a criminal record or other information will not debar you from gaining a licence unless the Council considers that the conviction renders you unsuitable. In making this decision the Council will consider the nature of the offence, how long ago and what age you were when it was committed and any other factors which may be relevant. Any applicant refused a drivers licence on the grounds that he/she is not a fit and proper person to hold such a licence has a right of appeal to a Magistrates Court.
