The Council is a Local Planning Authority for the purpose of the Town and Country Planning Act 1990 for the area within which the property described in the First Schedule hereto is situated (hereinafter called "the Property") which Property is shown edged red on the plan attached hereto (hereinafter called "the Plan")

The Applicant has by an application registered on the 26th May 2005 applied to the Council for planning permission to develop the property in accordance with the plans specifications and particulars deposited with the Council and set out in the Second Schedule hereto (hereinafter called "the Development")

 permission in accordance with the Grant of Planning Permission ("the Grant")
 annexed hereto but subject to the conditions set out in the Grant
- The Applicant hereby covenants with the Council that the Property shall be subject to the restrictions and provisions specified in the Third Schedule hereto

- 4. The Applicant hereby covenants to carry out the Development in strict conformity with the said plans specifications and particulars (save for such minor modifications and variations thereof as shall be approved by the Council in writing)
- 5. The expressions "the Council" and "the Applicant" shall include their respective successors in title and assigns
- 6. The parties hereto intend this Agreement to take effect as a Deed

That the dwelling to be created on the said property shall not be occupied for any other purpose other than as holiday accommodation.


