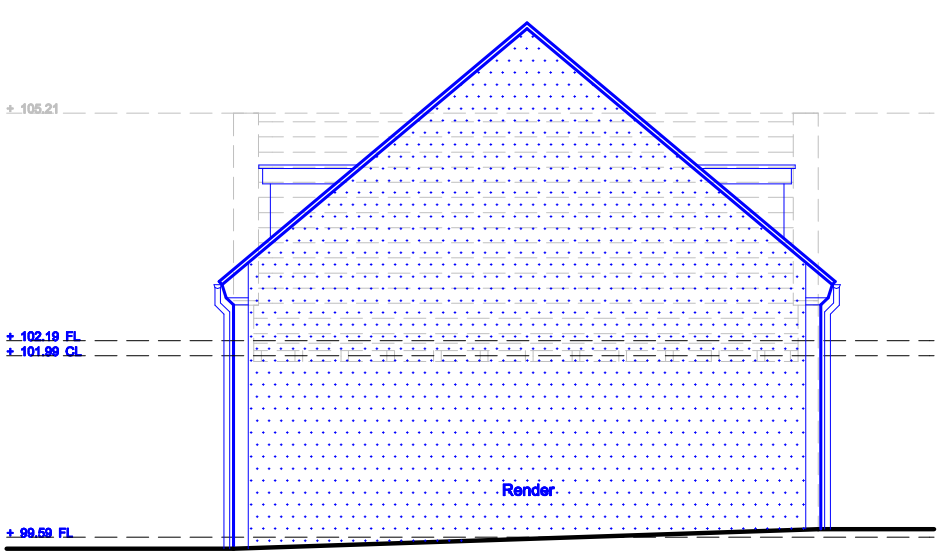


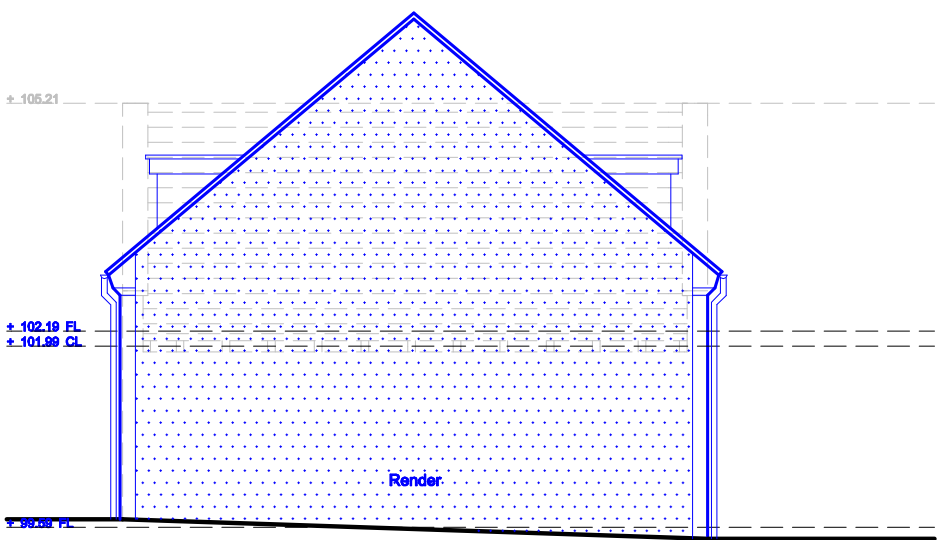
PROPOSED SITE PLAN



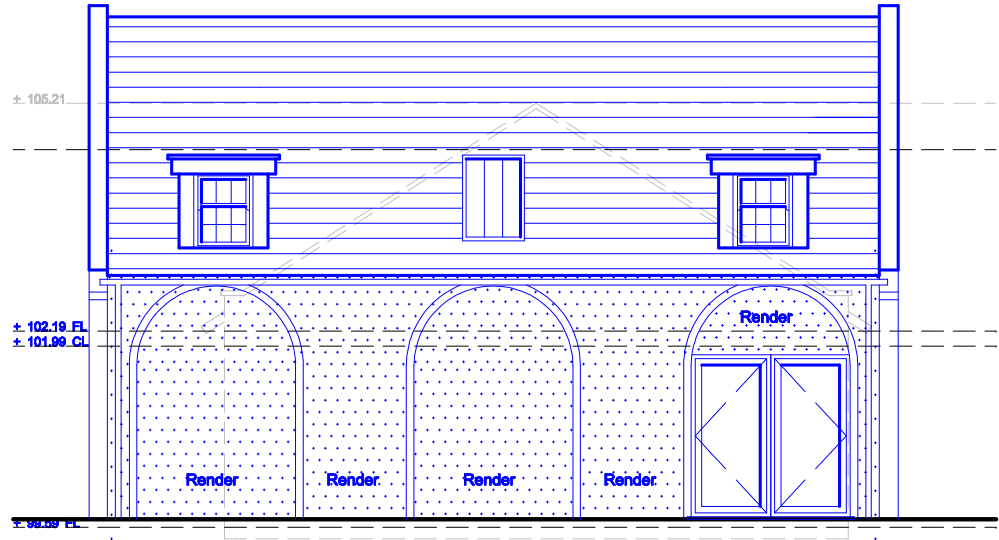
PROPOSED COACH HOUSE  
FRONT ELEVATION



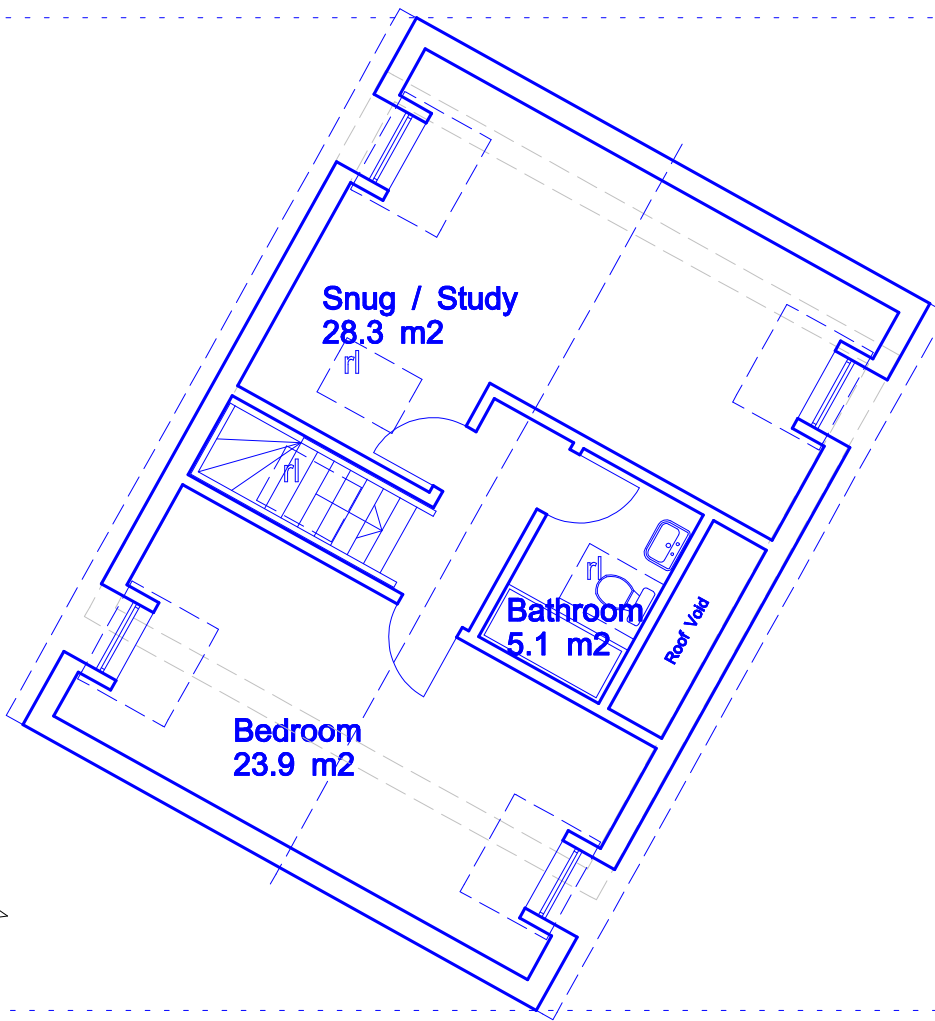
PROPOSED COACH HOUSE  
SIDE ELEVATION



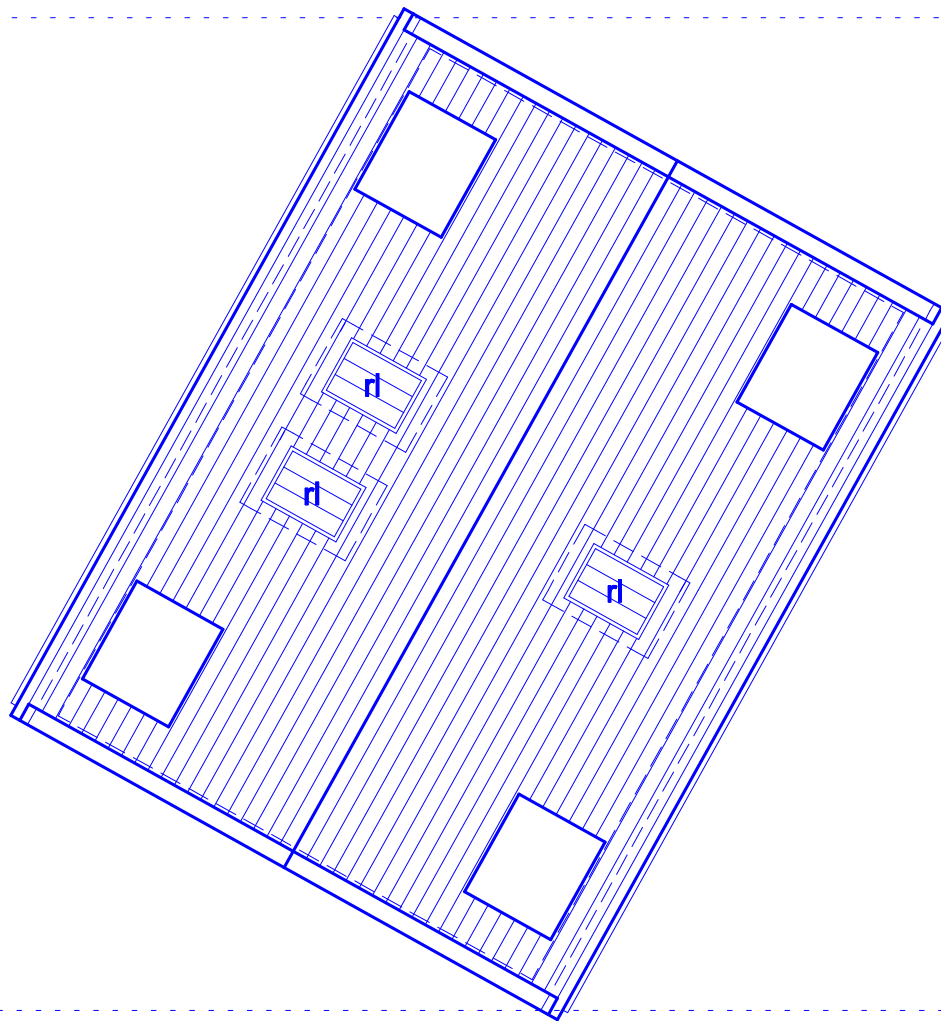
PROPOSED COACH HOUSE

ROOF PLAN

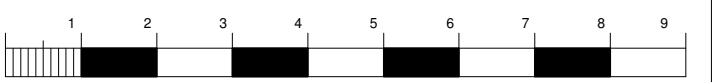

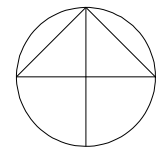
