Education Response

04/2025/2020/0F1 - Scalegill Farm, Moor Row

This is a hybrid (outline/full) application for 22 houses on 1.3 hectares of land at Scalegill Farm, Moor Row.

The housing breakdown has been provided as: 11 x 3 bed, 11 x 4+ bedroomed houses. Using a dwelling-led model on the 22 units it is theoretically estimated to yield 15 children: 9 primary and 6 secondary pupils for the schools.

The primary catchment school for this development is Moor Row School (0.4 mile measured from approximate centre of the site of the proposed houses) and West Lakes Academy is the catchment secondary for this development (2.5 miles). The next nearest schools are Valley Primary (1.6 miles) and The Whitehaven Academy (2.3 miles).

Office of National Statistics pupil yield data for Cumbria has been used to calculate yield according to the number and type of housing in a development.

The methodology for calculating available spaces in schools first considers developments with planning approval, before assessing which schools the developments will impact and what spaces remain for the most recently proposed development. Currently there are six developments affecting the primary schools used for this assessment and thirty-two affecting the secondary schools. The table below shows both the catchment schools and the developments that will affect them.

- PAN Capacity the total capacity of the school based on the Published Admission Number (PAN) x the number of year groups in the school.
- Average spaces shows the average number of available places in a school per year over the projection period, these are spaces in the school before any housing development is considered.
- Development site the site of a proposed development.

- Houses the number of houses in the proposed development.
- Primary/Secondary yield the number of primary or secondary children that will be yielded from the development.
- **Spaces** yield the number of spaces left in all the schools within the 2/3 mile distance from the centre of the development.

PRIMARY

After other developments in the area are taken into consideration there are insufficient spaces in the catchment school Moor Row. However, there are sufficient places in Valley Primary and Hensingham Primary School to accommodate the primary pupil yield of 9 from this development. Both schools are within the walking distance threshold of 2 miles.

An education contribution would not be required for primary education.

SECONDARY

There are insufficient places available in the catchment school of West Lakes Academy to accommodate the secondary pupil yield of 6 from this development. After other developments in the area are taken into consideration, there are insufficient spaces in the next nearest schools of Whitehaven Academy and St Benedict's Catholic High School.

A contribution of £163,920(6 x £27,320) would be required for secondary education.

NB. Projections represent a snapshot in time and all figures can be subject to change as further information becomes available.

It should be noted that there may be other potential developments that may affect these schools, but as they have not been approved at this stage, have not been included in the calculations.
