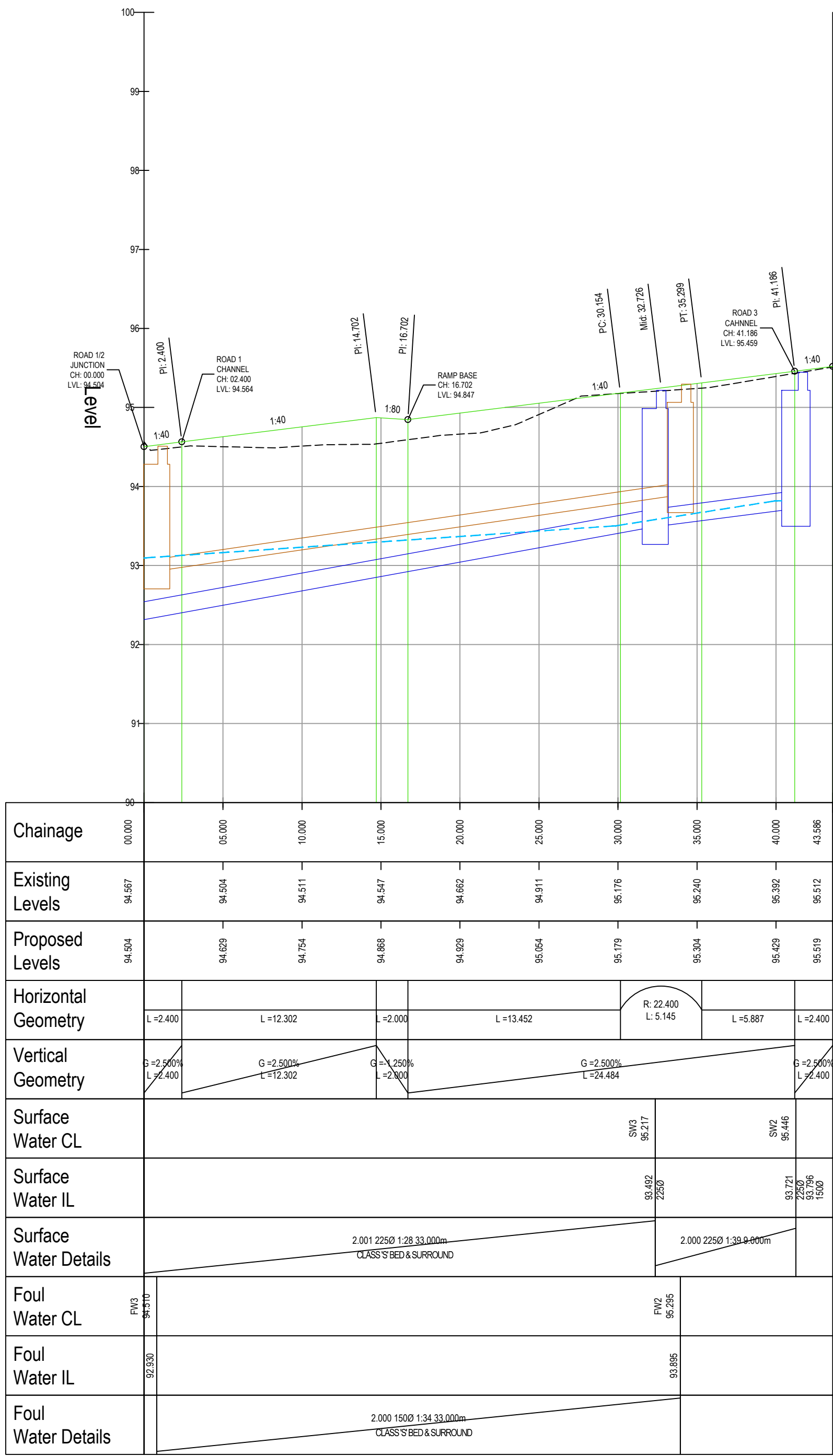
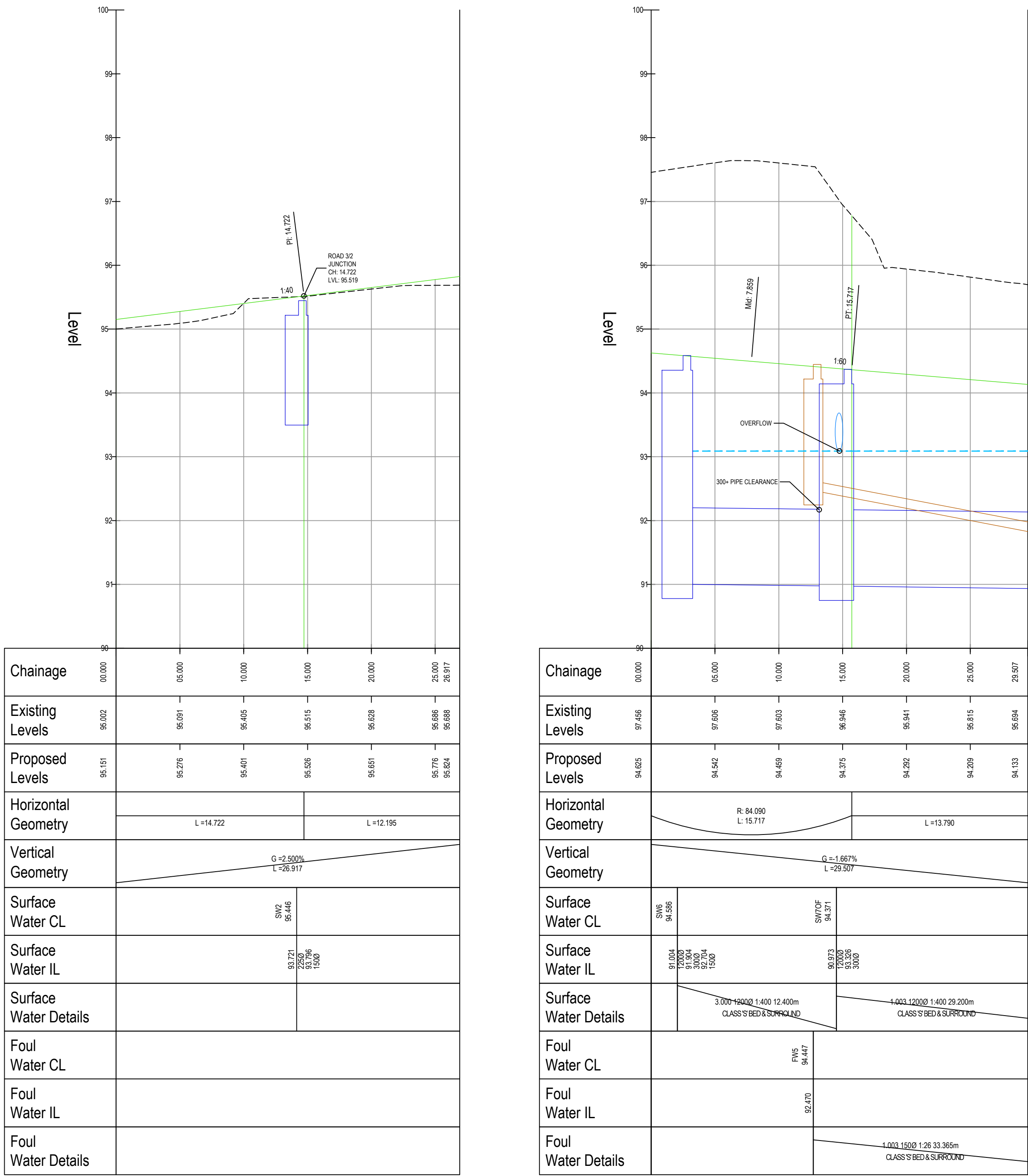


ROAD1 - LONGSECTION

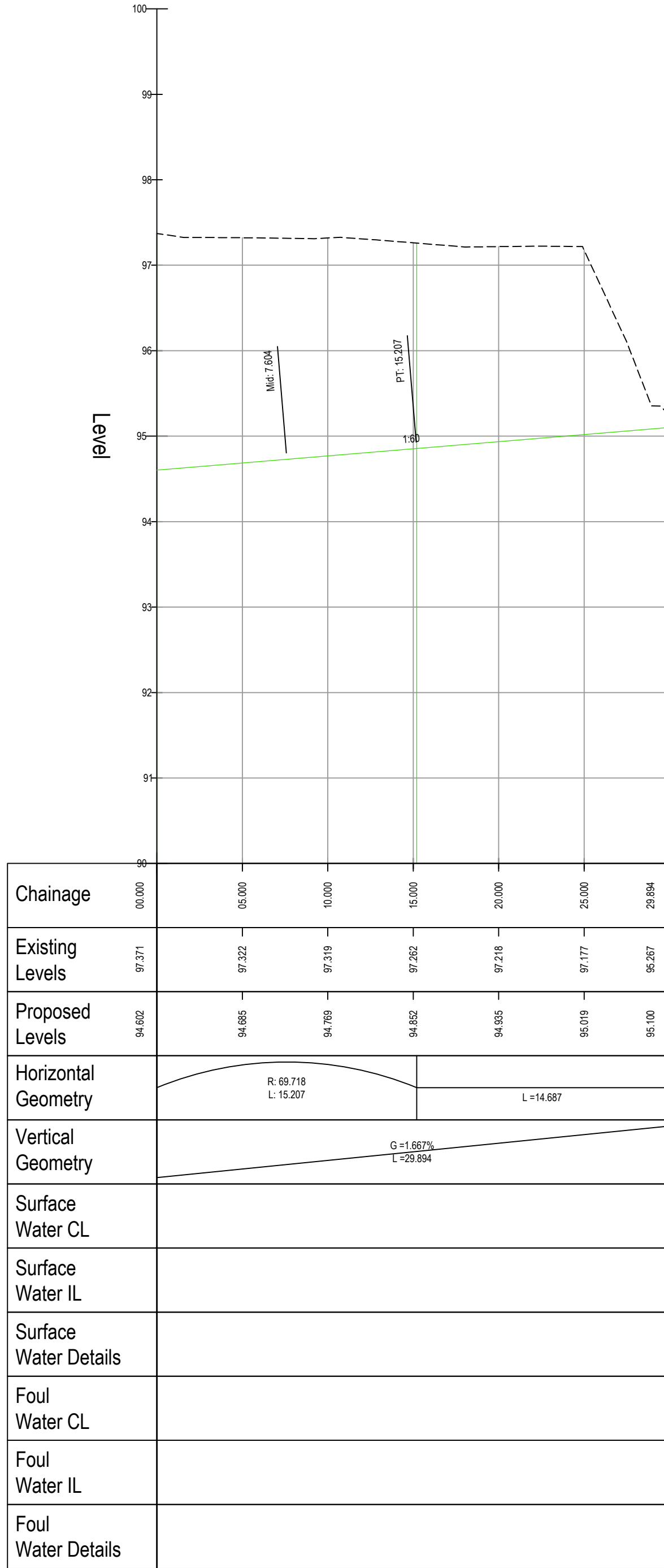

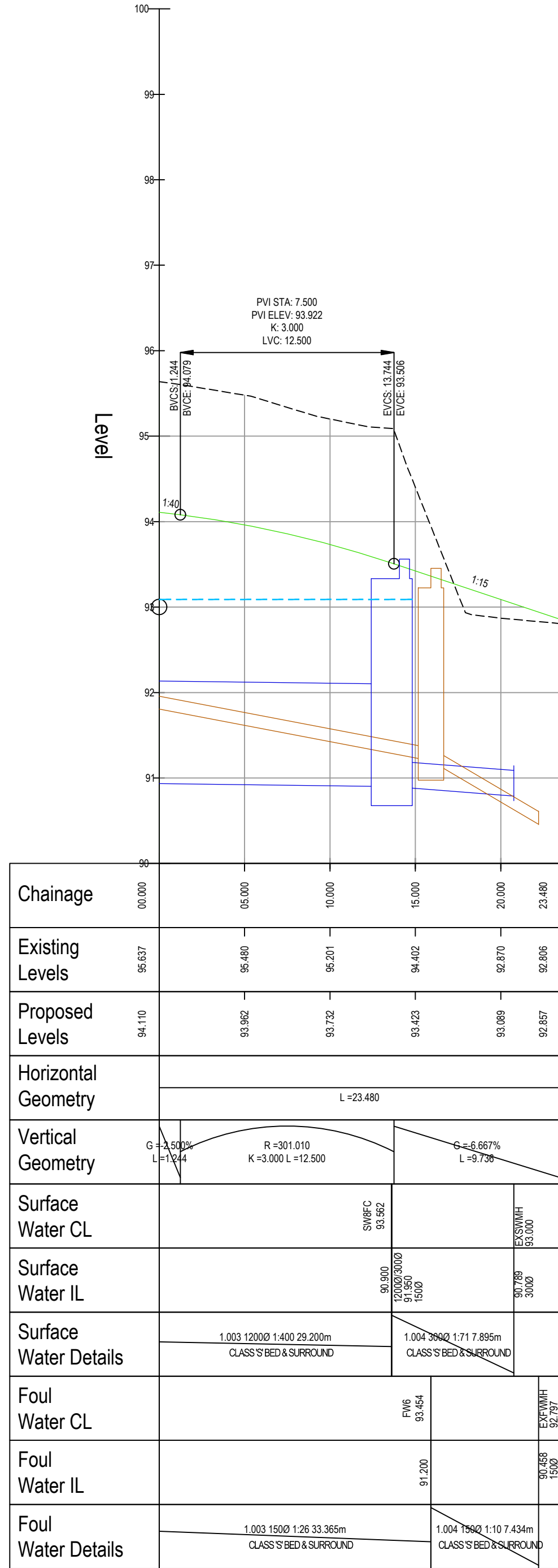
SD3A - LONGSECTION

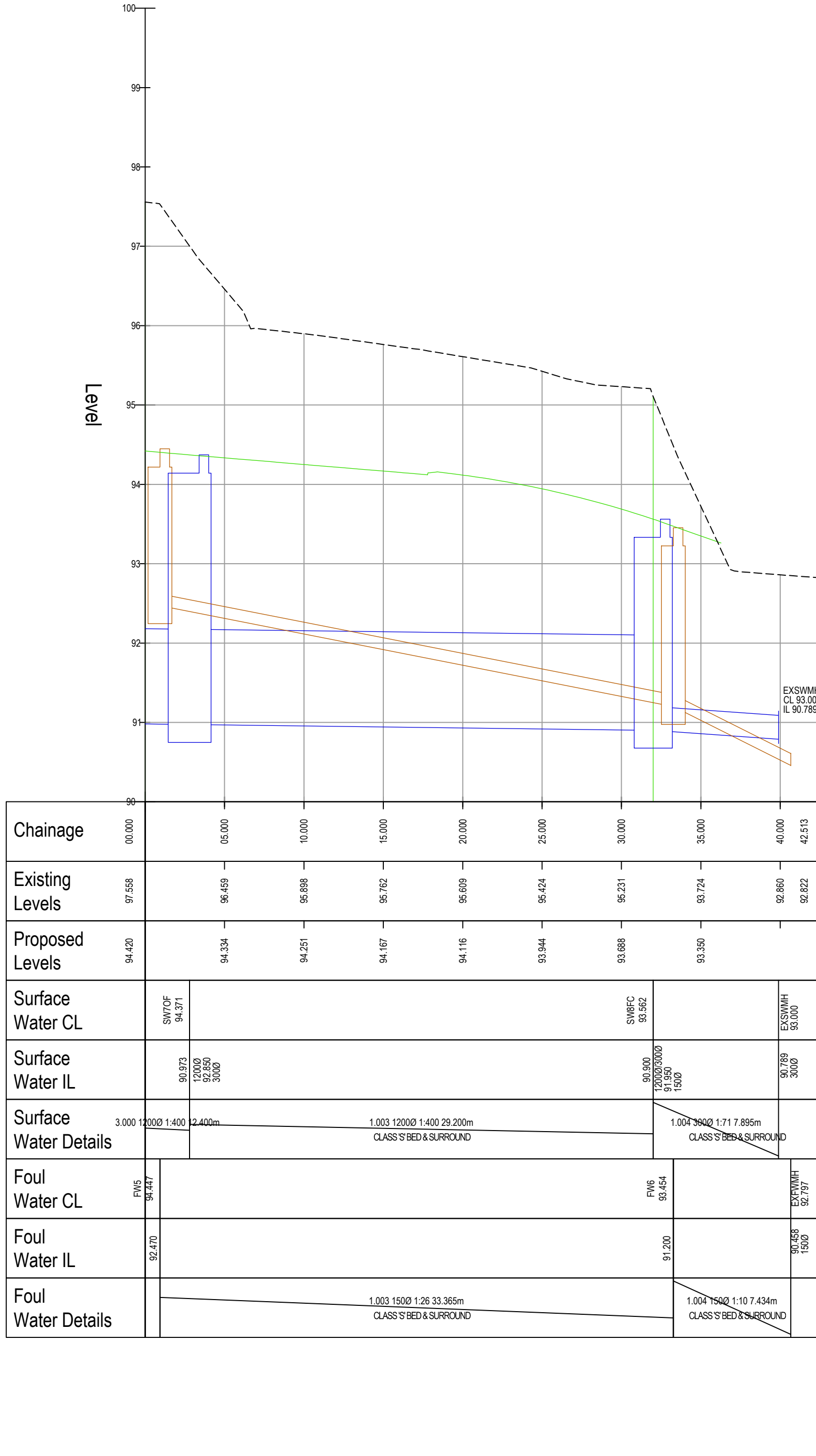
SD3B - LONGSECTION
