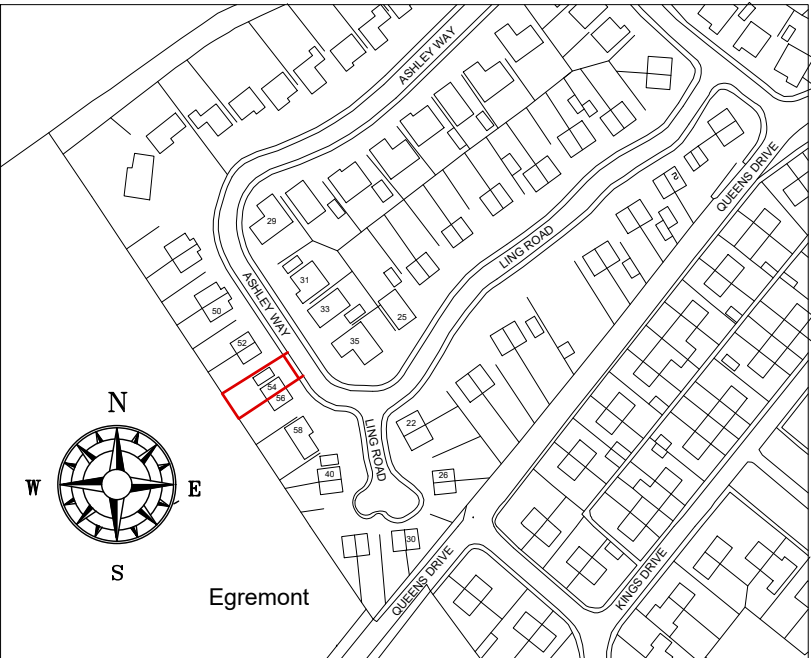
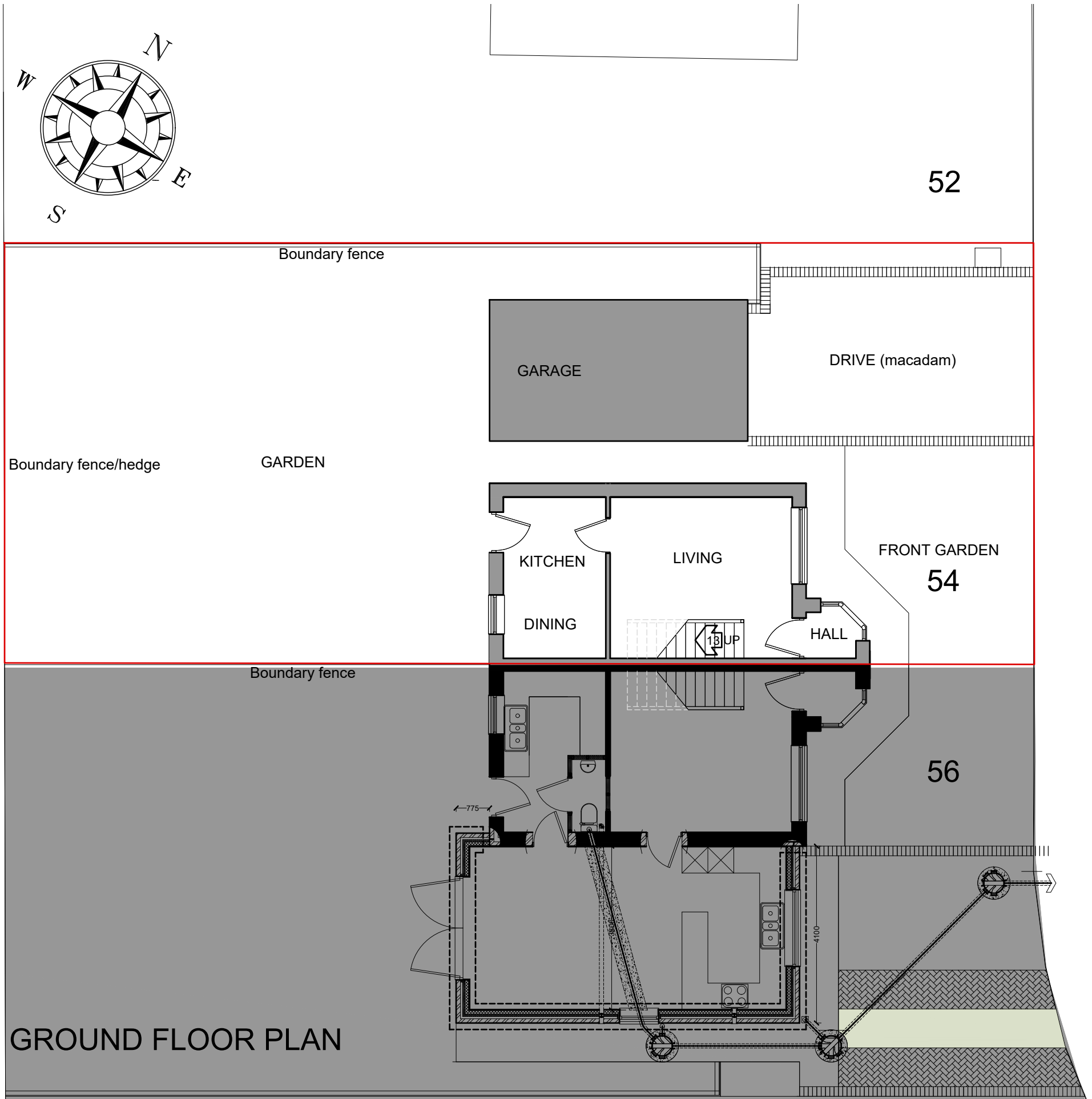
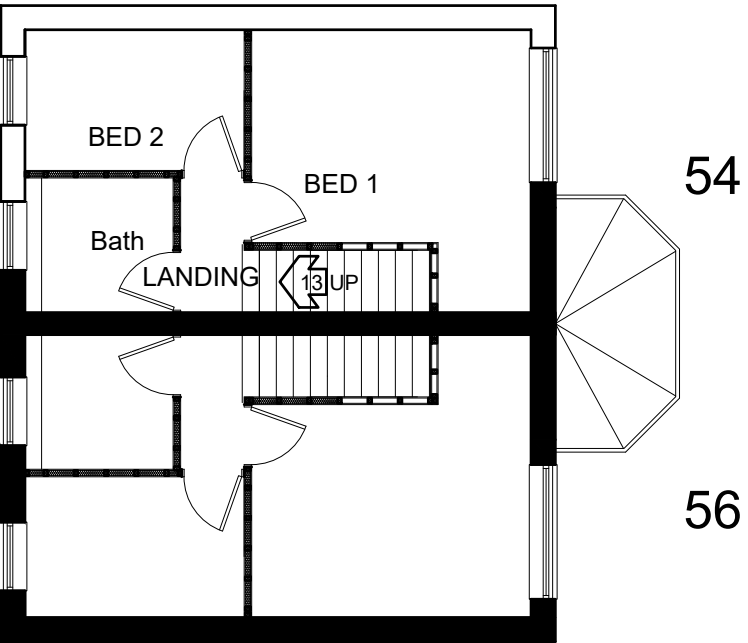




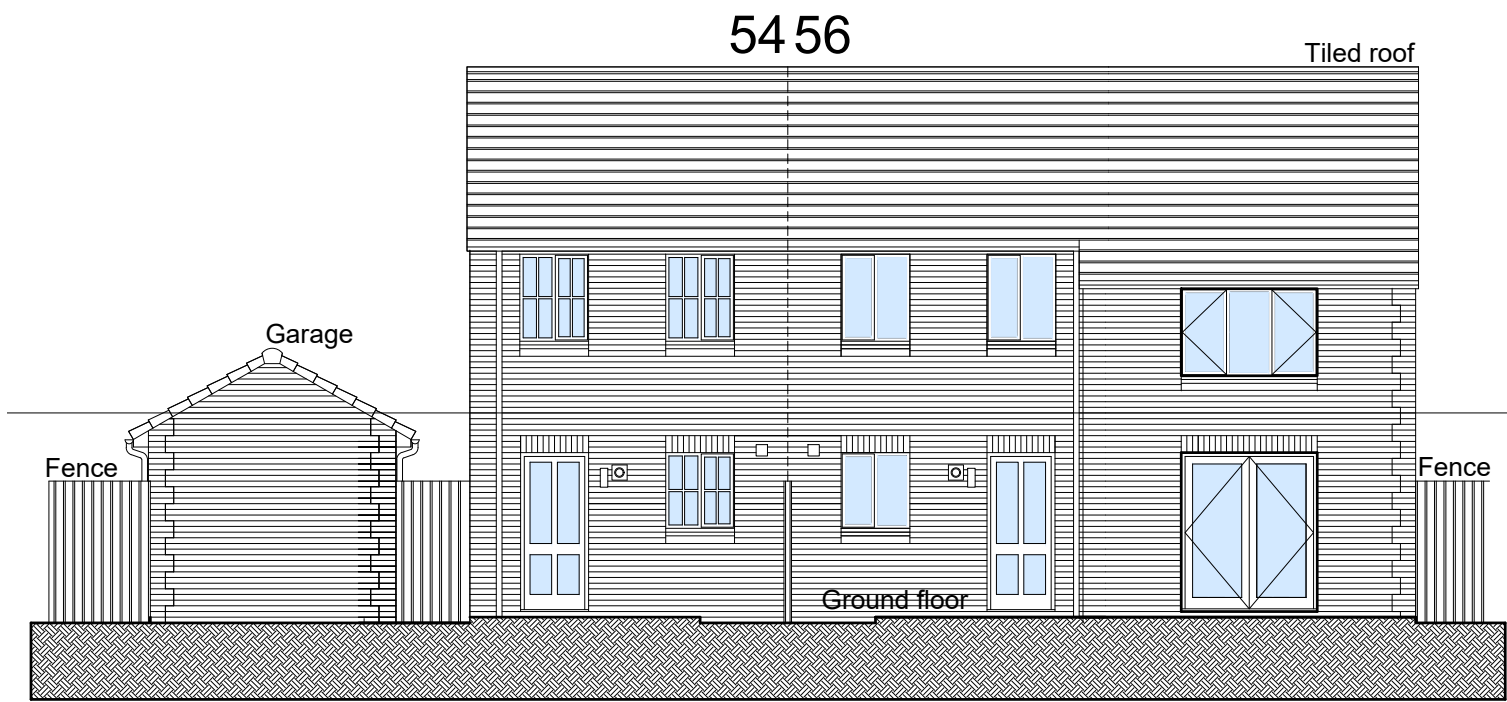
LOCATION PLAN 1/2500 Scale



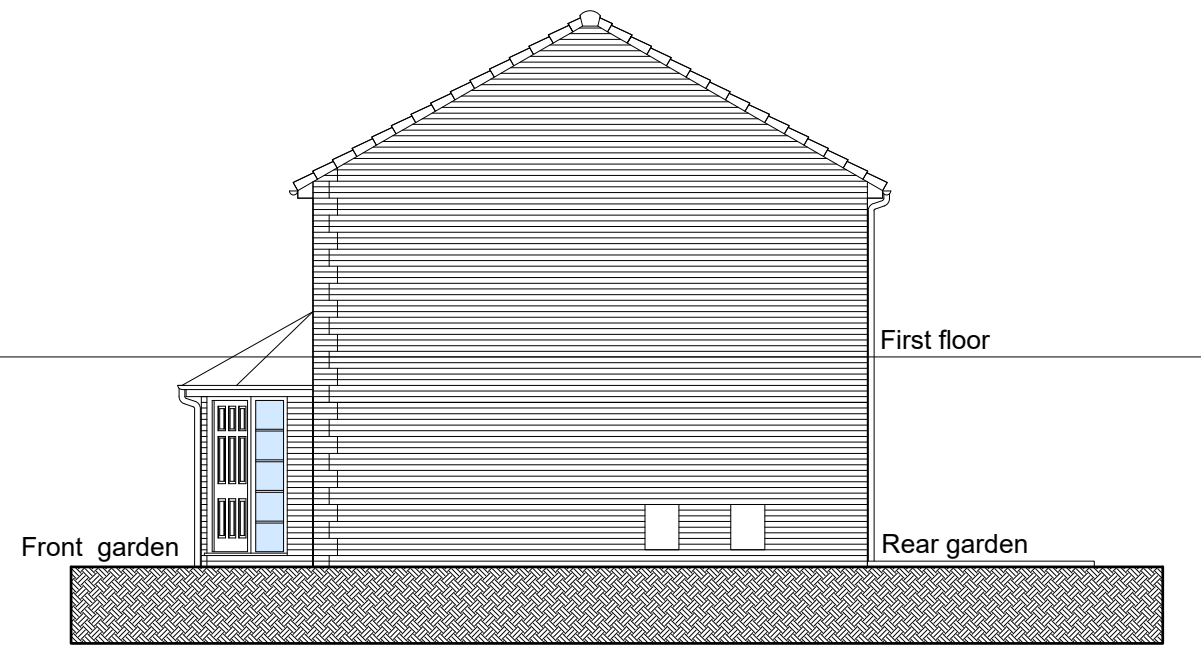
