THE REMOVAL AND REPLACEMENT OF AN EXISTING 12 METRE HIGH TELECOMMUNICATIONS POLE WITH A 20 METRE HIGH TELECOMMUNICATIONS LATTICE TOWER WHICH WILL SUPPORT 3NO. RADIO ANTENNAS, 2NO. TRANSMISSION DISHES AND ANCILLARY EQUIPMENT, ALONG WITH GROUND BASED CABINETS AND ANCILLARY DEVELOPMENT AT LOW STOWBANK FARM, KIRKLAND ROAD, ENNERDALE, CLEATOR, CUMBRIA, CA23 3AL
