I would confirm that the following works are considered to be unacceptable to the Local Planning Authority and consequently this part of your application has been **<u>REFUSED</u>** for the following reasons:

			No substantive arboricultural justification has been provided to support the removal of these trees. Any replacement trees, either self-seeded or planted, will take many years to grow to a sufficient size to make a similar contribution to the visual amenity of the location as those proposed for removal.



No evidence is provided to indicate that T15
presents a risk. The tree is typical of many
growing in groups and many at this location.

For the reasons detailed above, our arboriculturist has recommended this part of the application for refusal. For your information a copy of the Council's Consultant Arboriculturalist's report is enclosed.

## **Your Right of Appeal**

## **Compensation**
