7.	Report: LOCATION This application relates to 7 Victoria Road, a semi-detached property located within Whitehaven. PROPOSAL Planning Permission is sought for the demolition of the existing rear conservatory and coal-bunker and its replacement with a single-storey rear wrap around extension. The proposed extension will project 3.31 metres from the rear elevation of the dwelling house and 6.075 metres from the rear elevation of the garage and it will have an overall width of 8.322 metres. It has been designed to include a flat roof, with an overall height of 3.6 metres and it will be lit by a 1 metre x 2 metre roof lantern. The rear elevation has been designed to include patio doors from the utility and the kitchen-dining area with steps down to the garden. Both side elevations will be blank. The extension will be finished with white K-Render, a black or anthracite Ruberoid cold installation liquid applied waterproofing product on the roof, anthracite aluminium doors and anthracite UPVC windows.

ASSESSMENT

The key issues raised by this proposed are its scale and design and the potential impacts on residential amenity.

Scale and Design

Policy ST1 and section 12 of the NPPF seek to promote high quality designs. Policy DM10 and DM18 seek to ensure domestic alterations are of an appropriate scale and design which is appropriate to their surroundings and do not adversely affect the amenities of adjacent dwellings.

The proposed replacement extension is relatively modest in scale and is appropriately sited within

	<p>the rear garden. The proposal is stepped away from the boundary and the design is considered to be suitable for its use. In addition, the choice of materials reflect the existing dwelling. On this basis, the proposal is considered to meet DM18(A) policy and the NPPF guidance.</p> <p><u>Residential Amenity</u></p> <p>Policy ST1, Policy DM18 and section 12 of the NPPF seek to safeguard good levels of residential amenity of both the parent property and adjacent dwellings.</p> <p>Overlooking and overshadowing issues between the proposed extension and the neighbouring properties were considered, although the flat roof design will reduce potential overshadowing issues and there are no proposed windows on the side elevations. The design is therefore considered to mitigate potential amenity issues.</p> <p>In addition, under current permitted development rights, an extension could project 3 metres from the rear elevation without the requirement for formal planning permission. This fall-back position is a material consideration in the assessment of this application. As the projection is not significantly larger than what is possible under permitted development, this proposal is considered to be satisfactory and therefore the proposal will not have a detrimental impact on the neighbouring amenity.</p> <p>On this basis, it was considered that the proposal will not have a significant impact on neighbouring amenity and therefore, the proposal is considered to meet Policy DM18 and the NPPF guidance.</p> <p><u>Conclusion</u></p> <p>Overall, this is considered to be an acceptable form of development which accords with the policies set out within the adopted Local Plan and the guidance in the NPPF.</p>
