#### Reason

# **Prior to Occupation Conditions**

3. Prior to the first occupation of any dwelling hereby approved the proposed landscaping must be carried in accordance with the approved document 'Landscape Structure Plan – 3 Plots (Amended), Scale 1:500, Drawing No: M3332-PA-020V02, received by the Local Planning Authority on the 1<sup>st</sup> April 2021'. The development must be retained in accordance with this approved detail at all times thereafter unless agreed in writing with the Local Planning Authority.

## Reason

To enhance the appearance of the development in the interest of visual amenities of the area and to ensure a satisfactory landscaping scheme.

- 4. Prior to the first occupation of any dwelling hereby approved the first floor gable windows must be fitted with obscure glazing in line with the approved documents:
  - Plot 1 Plans & Elevations (Amended), Scale 1:100, Drawing No: 18/07/935-09, received by the Local Planning Authority on the 29<sup>th</sup> March 2021.
  - Plot 2 Plans & Elevations (Amended), Scale 1:100, Drawing No: 18/07/935-06a, received by the Local Planning Authority on the 29<sup>th</sup> March 2021.
  - Plot 3 Plans & Elevations (Amended), Scale 1:100, Drawing No: 18/07/935-05a, received by the Local Planning Authority on the 29<sup>th</sup> March 2021.

The obscure glazing must be permanently retained at all times thereafter.

Reason

To safeguard the amenities of occupiers of adjoining properties.

# Prior to Erection of External Walling Conditions

5. Prior to the erection of any external walling relating to the development hereby approved representative samples of the materials to be used on the external surfaces of the development hereby permitted must be submitted to and approved in writing by the Local Planning Authority. The development must be carried out in accordance with the approved details and so maintained thereafter.

Reason

To ensure a satisfactory appearance of the development in the interests of visual amenity.

- Prior to the commencement of this development, the requirements of Planning Conditions 5, 10, 11, 12, 13, 15, and 16 of Outline Planning Approval Ref: 4/18/2465/001 are required to be submitted and approved in writing by the Local Planning Authority.

#### PART 2

#### **TOWN AND COUNTRY PLANNING ACT 1990**

## **Appeals to the Secretary of State**

- If you are aggrieved by the decision of your local planning authority to refuse permission for the proposed development or to grant it subject to conditions, then you can appeal to the Secretary of State under section 78 of the Town and Country Planning Act 1990.
- If you want to appeal against your local planning authority's decision then you must do so within 6 months of the date of this notice.
- Appeals can be made online at: <a href="https://www.gov.uk/planning-inspectorate">https://www.gov.uk/planning-inspectorate</a>.
   If you are unable to access the online appeal form, please contact the Planning Inspectorate to obtain a paper copy of the appeal form on tel: 0303 444 5000.
- The Secretary of State can allow a longer period for giving notice of an appeal but will not normally be prepared to use this power unless there are special circumstances which excuse the delay in giving notice of appeal.
- The Secretary of State need not consider an appeal if it seems to the Secretary of
  State that the local planning authority could not have granted planning permission
  for the proposed development or could not have granted it without the conditions
  they imposed, having regard to the statutory requirements, to the provisions of any
  development order and to any directions given under a development order.
- If you intend to submit an appeal that you would like examined by inquiry then you must notify the Local Planning Authority and Planning Inspectorate (inquiryappeals@planninginspectorate.gov.uk) at least 10 days before submitting the appeal. Further details are on GOV.UK.

## **Purchase Notices**

- If either the Local Planning Authority or the Secretary of State refuses permission to develop land or grants it subject to conditions, the owner may claim that he can neither put the land to a reasonably beneficial use in its existing state nor render the land capable of a reasonably beneficial use by the carrying out of any development which has been or would be permitted.
- In these circumstances, the owner may serve a purchase notice on the Council (District Council, London Borough Council or Common Council of the City of London) in whose area the land is situated. This notice will require the Council to purchase his interest in the land in accordance with the provisions of Part V1 of the Town and Country Planning Act 1990.
