1. The felled tree is to be replaced during the first available planting season following the felling operation by one 6-8cm girth light standard English oak as close to the location of the tree they replace, or such other size, species, location or period as may be agreed in writing by the Local Planning Authority. If a replacement tree dies, becomes diseased or is damaged within 5 years of the date it is planted it must be replaced in the next available planting season by others of a similar size and species.

Reason

To ensure the continuity of amenity in accordance with 'Policy DM28 – Protection of Trees' of the Copeland Local Plan 2013-2028.

Your Right of Appeal
