I refer to your application of 01/08/2022 under the above Tree Preservation Order for consent to carry out the following work:-

I would confirm that there are no objections to the proposal, subject to the following conditions:-

	Sycamore	a tree preservation order	Planting

The four felled trees are to be replaced during the first planting season following the work. Plant 2x Silver Birch (Betula pendula) and 2x Sessile Oak (Quercus petraea), 6-8cm girth and 'light-standard', within 3m of the felled trees they replace. Alternatively, another size, species, location or period should be agreed in writing by the Local Planning Authority. If a replacement tree dies, gets diseased, or is damaged within 5 years of the date of planting, it must be replaced in the next available planting season by another of a similar size and species.

## Reason

To ensure the continuity of amenity in accordance with 'Policy DM28 – Protection of Trees' of the Copeland Local Plan 2013-2028.

## Your Right of Appeal
