REMOVAL OF A CHESTNUT TREE PROTECTED BY A TREE PRESERVATION ORDER BRAITHWAITE COURT, EGREMONT

I refer to your application of 08/08/2022 under the above Tree Preservation Order for consent to carry out the following work:-

I would confirm that there are no objections to the proposal, subject to the following conditions:-

The felled tree must be replaced during the first planting season following the work. Plant 1x Hornbeam (Carpinus betulus), 6-8cm girth and 'light-standard', within 3m of the felled tree it replaces. Alternatively, another size, species, location, or period should be agreed in writing by the Local Planning Authority. If the replacement tree dies, gets diseased, or is damaged within 5 years of the date of planting, it must be replaced in the next available planting season by another of a similar size and species.

Reason

To ensure the continuity of amenity in accordance with 'Policy DM28 – Protection of Trees' of the Copeland Local Plan 2013-2028.



For your information a copy of the Council's Consultant Arboriculturalist's Report is enclosed.

Your Right of Appeal

If you disagree with our decision you can appeal to The Planning Inspectorate, Environment and Transport Team, 3/A Eagle Wing, Temple Quay House, 2 The Square, Temple Quay, Bristol, BS1 6PN within 28 days from the date you received this decision.

Compensation

If you suffer any loss or damage as a result of a condition attached to this consent, you might be entitled to recover compensation from the Council. If you wish to make a claim you must do so within 12 months from the date of this decision (or, if you appeal to the Secretary of State, within 12 months from the date of this decision).
