The felled tree is to be replaced during the first planting season following the work. Plant 1x Silver Birch (Betulina pendula), 6-8cm girth and 'light-standard', within 5m of the felled tree it replaces. Alternatively, another size, species, location or period should be agreed in writing by the Local Planning Authority. If the replacement tree dies, is diseased, or damaged within 5 years of the date of planting, it must be replaced in the next available planting season by another of a similar size and species.

Reason

To ensure the continuity in accordance with 'Policy DM28 – Protection of Trees' of the Copeland Local Plan 2013-2028.
