CROWN REDUCTION BY 1-2M AND CROWN LIFT UP TO 2.5M OF A BIRCH TREE PROTECTED BY A TREE PRESERVATION ORDER LAND TO REAR OF 15 TO 20 SCOTCH STREET, WHITEHAVEN

I refer to your application of 13/02/2024 under the above Tree Preservation Order for consent to carry out the following work:-

CROWN REDUCTION BY 1-2M AND CROWN LIFT UP TO 2.5M OF A BIRCH TREE PROTECTED BY A TREE PRESERVATION ORDER

T1	Birch	Crown reduction of 1-2m and crown lift up to 2.5m	In accordance with BS3998:2010 Tree Works – Recommendations

Carry out all pruning work in accordance with BS3998:2010 Tree Works – Recommendations, particularly sections 7.6 'Crown Lifting' and 7.7 'Crown reduction and reshaping'. Restrict all pruning wounds to a maximum of 50mm diameter.

Reason

In accordance with Section 198 of the 1990 Town and Country Planning Act and in the interest of good arboricultural practice.

For your information a copy of the Council's Arboriculturalist's Report is enclosed.

Your Right of Appeal

Compensation
